**H2O Vivace FCP's** active management approach seeks to generate performance on all international fixed income, currency, credit, and equity markets regardless of market environments. The management team implements directional strategies (linked to the general direction of the markets) as well as relative value positions and arbitrages (linked to the relative movements of the markets in relation to each other) on the bond, credit, foreign exchange and equity markets.

It should be reminded that the fund's relative performance management is fed by all of the investment team's views on the government bond, credit, equity and currency markets, through strategies based on directional, relative value and thematic (or specific) approaches.

The performance of H2O Vivace FCP over the period was generated on its four reference asset classes as follows:

- International sovereign bonds strategies contribute positively to performance. The fund's allocation profits from its short duration stance on sovereign debt from countries that make up the G4 (United States, Germany, Japan, United Kingdom). Significant gains are also generated from the arbitrage carried out between issuances of these countries, benefiting in particular from the widening of the transatlantic spread (US / German 10-year rates) until April 2022, as well as on yield curve arbitrages which focused on the flattening of US and German yield curves. Conversely, the long position on Italian BTPs against German Bunds suffers from the increase in the 10-year spread from June 2021 to June 2022 (+92 bps).
- 2. <u>The contribution from FX strategies is negative.</u> The fund bears the cost of its short dollar positioning against G3 currencies (JPY, EUR, CAD) as the greenback appreciates drastically over the concerned period (US dollar index (DXY): +8%). Inter-block and intra-block investment strategies also provide negative returns given, in the first case, the decline of the Japanese yen against the euro and the Canadian dollar in the second half of the year and, in the second case, the fall of the EURCHF and AUDCAD pairs. However, the fund's large allocation to currencies from emerging countries, in particular the Brazilian real, the Mexican peso and the Russian rouble, provides gains.
- 3. <u>Credit market Strategies exhibit negative returns</u> mainly due to the allocation in external debt from sovereign governments, which is strongly impacted by the fall in value of Turkish issuances over the whole period, and of Russian and Ukrainian bonds during the first quarter of 2022.
- 4. <u>The contribution from equity strategies is strongly positive this year</u> mainly due to the arbitrage of US blue chips against small and mid-caps. H2O Vivace FCP's sector allocation is slightly positive thanks to the rally of financial and automotive companies in January 2022. However, the regional arbitrage (long European stocks vs. American stocks) comes out negative given the relative outperformance of the US stock market. Returns from the fund's directional exposure are almost flat over the period.

#### Post-closing event

On June 3, 2022, the European Commission placed the National Settlement Depository (NSD\*) on the list of sanctioned entities / persons following the invasion of Ukraine by Russia. Consequently, certain transactions involving the NSD are now prohibited (see on this topic the FAQ published on August 12, 2022 by the European Commission providing details on the authorised and prohibited activities). The various interpretations of the sanctions relating to Russia made by financial market participants lead the management company to take these exogenous factors into account in its analyses.

#### Material changes during the period and expected in future

The following changes occurred to the prospectus on January 1, 2022 :

Change in the benchmark indices, and consequently, in the management objective, in application of European regulations on benchmark indices (Regulation (EU) 2016/1011 – *Benchmarks Regulation* (BMR) of 08/06/2016).
 Thus, the EONIA and LIBOR indices, meant to disappear, have been replaced.

The new benchmarks, in line with the place recommendations, are :

- €STR (Euro Short Term Rate) Capitalised instead of capitalised EONIA,
- o SARON (Swiss Average Rate Overnight) capitalised instead of LIBOR CHF 1 month,
- o SOFR (Secured Overnight Financing Rate) Capitalised instead of 1-month USD LIBOR.

This change had no impact on the management of the UCITS but did have an impact on costs. It has led (in the case of the replacement of EONIA) or could have led (in the case of the replacement of LIBOR rates) to an increase in variable costs (outperformance fees are/could have been provisioned more quickly).

Indeed, the EONIA is indexed on the  $\in$ STR and is expressed by the following equivalence formula :

EONIA = €STR +8.5 basis points.

On the other hand, the SARON and SOFR rates do not have a fixed spread with the old LIBOR rates.

- Insertion of a statement relating to European regulation 2020/852 of 06/18/2020 called "Taxonomy" which sets the criteria for determining whether an economic activity is "sustainable" from an environmental point of view in the European Union. We remind you that the FCP falls under Article 6 of European Regulation 2019/2088 known as "SFDR".
- Modification of the "Outperformance Fee" section in accordance with ESMA guidelines dated November 05, 2020 (ESMA 34-39-992).

Furthermore, as part of the reorganization of the management teams following Brexit, the financial management delegation to H2O AM LLP (London) has come to an end. The management of the UCITS is now implemented from Paris by a team composed of managers from H2O AM Europe previously in charge of global macro UCIs in London. A financial management delegation to H2O Monaco S.A.M has been set up; the Monegasque management team is required to contribute to the management of the UCITS.

The annual realised (ex-post) volatility target has been removed insofar as the management company preferred to commit to a maximum estimated (ex-ante) risk budget within which it calibrates its investment strategies.

In addition, the level of leverage (given as an indication) has increased from 20 to 46. The reason for this is the observation made by the management company that traditional risk measures would not make it possible to quantify the amplitude of the most extreme market events, like those witnessed in March 2020. They therefore had to be supplemented by new protection strategies which added to the existing positions and thus increased the UCITS' commitment (leverage) without increasing the risk.

Finally, the section relating to the investment rules specified that henceforth, in compliance with the regulatory ratios, the UCITS may invest up to 100% of its assets in securities guaranteed by a State, a local authority and/or an international public organisation, provided that this 100% is spread over at least six issues, none of which should represent more than 30% of the assets.

The following changes occurred to the prospectus on June 1, 2022 :

The paragraph relating to forward foreign exchange (section VI RULES FOR VALUATION AND RECOGNITION OF ASSETS) has been supplemented by the mention :

"They can be marked to market based on the observed forward foreign exchange curves." This change in the practical terms of the rules for valuing and accounting for forward foreign exchange allowed a valuation of these instruments to be more representative of market conditions.

The "SFDR" section of the term sheet has been updated to account for the Management Company's policy of systematic exclusions and the addresses of CACEIS Bank and CACEIS Fund Administration have been updated following their change of headquarter office.

#### **H2O VIVACE FCP**

As of April 12, 2022 and in application of amended European regulation 833/2014 and European regulation 398/2022, subscriptions to new share classes from the fund were no longer allowed (insofar as the fund could offer exposure to securities issued in euros after April 12, 2022):

- To any Russian national, any natural person residing in Russia or any legal person, entity or organisation established in Russia and;

- To any Belarusian national, any natural person residing in Belarus or any legal person, entity or organisation established in Belarus.

#### c) Information about risks

#### Method for calculating total risk

The asset management company uses the VaR - absolute (VaR) method to calculate the fund's total risk.

-The UCI's average indicative leverage:

The UCITS's average indicative leverage level is 46. However, the fund may have a higher leverage level than this. During the financial year, the average leverage was 41.3. The fund's indicative leverage level is calculated as the sum of nominal positions on the financial contracts used.

The fund's VaR levels during the period:
The highest level to VaR - absolute reached was: 18.93%.
The lowest level to VaR - absolute reached was: 13.89%.
The average level to VaR - absolute was: 16.55%.

The VaR calculation method used is 20-days parametric with a 99% confidence interval. It is based on a six-year data history.

#### Exposure to securitisation

The UCI has no exposure to securitisation.

#### Risk management

As part of its risk management policy, the asset management company establishes a risk management policy and risk management procedures that are effective, appropriate and documented and that allow it to identify risks related to its activities, processes and systems.

For more information, please see the UCI's KIID and more specifically its "Risk and return profile" section, or its prospectus, which may be obtained on request from the asset management company.

#### Liquidity management

The portfolio management company has defined a liquidity management policy for its open-end UCIs, based on measurements and indicators that show illiquidity and the impact on portfolios in the event of forced sales following large-scale redemptions by investors. Measures are applied according to a frequency appropriate to the management type, according to various simulated redemption scenarios, and are compared with predefined alert thresholds. The liquidity of collateral is monitored weekly using identical parameters.

#### **H2O VIVACE FCP**

UCIs identified as sensitive because of the level of illiquidity identified or because of the impact of forced sales undergo additional analysis of their liabilities. The frequency of these tests changes according to the asset management techniques used and/or the markets in which the UCIs invest. As a minimum requirement, the results of these analyses are presented in governance committee meetings.

The asset management company therefore relies on a liquidity control and monitoring system that ensures that investors are treated fairly. Any change to this policy during an accounting period that affects the UCI's documentation will be indicated in the "material changes" section of this document.

#### Treatment of non-liquid assets

This fund is not concerned.

#### d) Environmental, social and governance (ESG) criteria

The UCI does not take into account all three ESG criteria at the same time.

#### SFDR :

Within the framework of the "SFDR" regulation (Regulation (EU) 2019/2088 of the European Parliament of November 27th, 2019 on the publication of information on sustainability in the financial services sector), this UCITS/IAF does not come under the Article 8, nor Article 9 of SFDR and, therefore, belongs to the category of funds covered by Article 6.

The main criteria taken into account in investment decisions are macroeconomic analysis, capital flows, and relative market valuation.

Consideration of sustainability risk (as defined in SFDR as an environmental, social, or governance event or circumstance that, should it occurs, could have a material, adverse impact on the value of an investment) is performed through systematic exclusions based on the regulations in place and the sectors and countries subject to international sanctions.

In addition, the investment firm, in the management of this UCITS/IAF:

- Excludes all actors involved in the production, use, storage, marketing, and transfer of anti-personnel mines and cluster bombs, in line with the Oslo and Ottawa conventions;

- Imposes additional control and approval from the Company's "Compliance" department for any investment linked to issuers based in countries identified as "high risk" in terms of combat against money laundering and terrorism financing (including in particular, but not exclusively, countries considered by the Financial Action Task Force (FATF) as exhibiting strategic deficiencies in their method for combating money laundering and terrorism financing, the European Union lists of high risk countries and non-cooperative jurisdictions for tax purposes, etc.).

The UCITS is currently unable to take into account the principal adverse impacts (or "PAI") of investment decisions on sustainability factors due to:

- A lack of availability of reliable data;

- The use of derivative financial instruments for which PAI aspects are not yet accounted for, nor defined.

#### Taxonomy (Regulation [EU] 2020/852) :

This UCITS/IAF's underlying investments do not take into account EU criteria regarding environmentally sustainable economic activities.

#### e) Energy Transition for Green Growth Act

The UCI does not prepare the report mentioned in Article 29 of the act.

### 2. Governance and compliance obligations

#### Procedure for selecting and assessing intermediaries and counterparties – Order execution

As part of the asset management company's compliance with its "best execution/best selection" obligation, the selection and monitoring of intermediaries are covered by a specific process.

#### Remuneration policy

H2O AM applies a remuneration policy in line with the UCITS V and AIFM directives. These directives imply that asset management companies must establish and apply remuneration policies and practices that encourage healthy and effective risk management and do not encourage risk-taking that is inconsistent with the UCI's risk profile.

The remuneration policy is subject to supervision and approval by a remuneration committee consisting of members who do not have executive roles within H2O. The remuneration policy is validated once per year by the H2O remuneration committee. The committee was set up in 2012 to ensure that remuneration arrangements support both H2O's strategic targets as well as the recruitment, motivation and retention of staff members, while complying with rules established by regulatory and governance authorities.

As regards the remuneration policy, the asset management company distinguishes between two categories of staff within H2O, regardless of whether they have portfolio management roles, i.e. employees and partners.

• Employees are paid a fixed salary in line with UK market practices plus an annual bonus based on their individual performance and their contribution to the overall business;

• Partners are paid a fixed salary and an annual bonus. They are also entitled to dividends based on their equity stake in the company, depending on the company's profitability.

The remuneration of the asset management company's staff, including "identified staff members" (i.e. material risk-takers who may affect the risk profile of the asset management company or the portfolios it manages) is based on the following principles and criteria:

• A risk management approach and a remuneration structure that are healthy, effective and consistent with the interests of the asset management company, portfolios and investors, including solid policies and procedures regarding valuations, risk management, liquidity and regulations;

· Employee wages that are in line with market levels in view of their roles.

### 2. Governance and compliance obligations

The asset management company only grants discretionary bonuses after it has added together and received performance and management fees for the period concerned. Variable remuneration, including the deferred portion, is discretionary, and so may fall to zero if negative returns occur.

#### Information about employees' remuneration

The asset management company has designated the following people as "identified staff members":

a) management;

b) portfolio management, client relations and business development staff members;

c) persons responsible for the middle office, quantitative development, finance, legal and human resources;

d) staff members with control functions; and

e) any employee whose total remuneration places him/her in the same remuneration bracket as management and risk-takers (b, c and d).

Apart from the identified staff members above, the asset management company does not have any material risk-takers.

Above defined thresholds, H2O ensures that a substantial proportion of any component of variable remuneration received by identified staff members is deferred and consists of :

a) units or shares in the UCITS where possible; or

b) equivalent stakes in the portfolios concerned where possible; or

c) share-based compensation relating to the portfolios concerned; or

d) equivalent non-monetary instruments relating to the portfolios concerned by incentives, which are as effective as any of the instruments referred to in points a) to c).

Instruments are subject to an appropriate retention policy designed to align incentives for staff members with the long-term interests of :

a) the portfolios they manage; and

- b) investors in those portfolios; and
- c) H2O.

The asset management company's staff members are remunerated solely by the asset management company itself and not by the portfolios they manage. H2O has ensured that all variable remuneration, including all deferred portions, is only paid or awarded if it is :

(1) Justified by the performance of :

a) portfolios;b) the commercial unit; andc) the person concerned; and

(2) Sustainable given H2O's overall financial position.

#### Opinion

#### Justification of Assessments

These matters were addressed in the context of our audit of the financial statements as a whole, established in the conditions mentioned above, and in forming our opinion thereon, and we do not provide a separate opinion on specific items of the financial statements.

#### Verification of the Management Report of the Fund's management company

We have also performed, in accordance with professional standards applicable in France, the specific verifications required by French law.

We have no matters to report as to the fair presentation and the consistency with the financial statements of the information given in the management report of the Fund's management company.

#### **Responsibilities of the Management Company for the Financial Statements**

The management company is responsible for the preparation and fair presentation of the financial statements in accordance with French accounting principles and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the management company is responsible for assessing the Fund's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless it is expected to liquidate the Fund or to cease operations.

The financial statements were approved by the management company.

#### b) Annual financial statements - Notes

#### 1. Accounting rules and methods

The annual accounts are presented as provided by the ANC Regulation 2014-01 modified.

General accounting principles apply:

- fair picture, comparability, going concern,
- regularity, trustworthiness,
- prudence,

- consistency of methods employed from one accounting period to another.

The accounting method used to record income from fixed-income securities is that of interest received.

Acquisitions and disposals of securities are recorded excluding costs. The reference currency for portfolio accounting is euros. The duration of the accounting period is 12 months.

### Asset valuation rules

Financial instruments are recorded in financial statements according to the historical cost method and recorded in the balance sheet at their current value which is determined by the last known market value or, in the absence of existing market, by any external means or by using financial models.

The differences between the current values used when calculating the net asset value and the historical costs of the securities when they entered the portfolio are recorded in "estimation differences" accounts.

Securities that are not denominated in the currency of the portfolio are valued in accordance with the principle outlined below, then converted into the currency of the portfolio according to the exchange rate on the day of the valuation.

#### Deposits:

Deposits with a residual life of less than or equal to 3 months are valued according to the linear method.

#### Equities, bonds and other securities traded in a regulated market or equivalent:

#### Equities:

French equities are valued on the basis of the last listed price if they are admitted to a deferred settlement system or to a spot market.

Foreign shares are valued on the basis of the last price on the Paris stock exchange when these securities are listed in Paris or on the first day of their main market converted in euros according to the WMR rate of the currency on the day of the valuation.

#### Bonds:

Bonds are valued on the basis of a Bloomberg composite rating retrieved at 5:00 p.m. (Paris time) in accordance with the WMR rate for the currency on the valuation date.

#### Valuation rules for Equities, bonds and other securities not traded on a regulated or similar market:

Transferable securities for which the price has not been recorded on the valuation date or has been adjusted are valued by the Management Company at their probable trading value.

In the case of transferable securities that are not listed or those for which a price is not listed on the valuation date, as well as other items on the balance sheet, the Management Company adjusts its valuation on the basis of variations that seem probable in view of current events. These valuations and their justification are communicated to the statutory auditor during his controls.

Foreign securities are converted into the equivalent value in euros in accordance with the WMR rate on the valuation date.

Following the invasion of Ukraine by Russia and international sanctions, the prices displayed by the various financial service providers for Russian government bonds are no longer representative of market conditions. Thus, as of June 30, 2022, the management company values these instruments as follows:

- For government bonds denominated in RUB, the bid is determined based on the information received from counterparties and is adjusted to take into account EU sanctions against the NSD. The ask is the price at which the management company has traded.
- For government bonds denominated in foreign currency (EUR and USD), the bid is determined according to the price quotes received from our counterparties and is adjusted if the security falls within the scope of EU sanctions against the NSD. The ask is determined according to the quotes received from our counterparties.

#### Negotiable debt securities:

Negotiable debt securities are valued according to the following rules:

- BTANs and BTFs are valued on the basis of an average of contributed prices recovered from market makers,
- Unlisted variable-rate debt securities are valued at cost adjusted for any changes in the credit spread,
- Other fixed-rate, negotiable debt securities (deposit certificates, commercial papers, financial institution notes, etc.) are valued on the basis of the market price.

In the absence of an indisputable market price, debt securities are valued by applying a yield curve possibly corrected by a margin calculated according to the characteristics of the security (of the issuer): However, debt securities whose residual life is less than or equal to 3 months are valued on a straight-line basis.

#### UCIs held:

Units or shares of UCITS/AIFs or investment funds are valued at the last known net asset value. Foreign undertakings for collective investment which perform their valuation within periods that are incompatible with the establishment of the FCP's net asset value are valued on the basis of estimates provided by the administrators of these UCIs under the control and responsibility of the management company.

#### Temporary corporate actions:

Temporary sales and acquisition contracts on securities and similar transactions are valued at the price of the contract adjusted for any margin calls (valuation according to the conditions provided for in the contract). For unlisted securities or those whose price was not quoted on the day of valuation, as well as for other items on the balance sheet, the management company's Executive Board corrects their valuation according to the variations that events in progress make probable.

Certain fixed-rate transactions with a term to maturity of more than three months may be marked to market.

### Firm and conditional forward transactions:

#### Organised, firm, and conditional forward markets:

Derivatives listed on an organised market are valued on the basis of the clearing price.

#### Forward foreign exchange:

They are valued at the exchange rate on the day of valuation, taking into account the amortisation of the deferment/discount.

From March 4, 2022 for contracts denominated in RUB(\*), and from June 1, 2022 for all other currencies, they are valued at the market price based on observed forward foreign exchange curves. Previously, they were valued at the exchange rate on the day of valuation, taking into account the amortisation of the deferment/discount.(\*) for contracts denominated in RUB and between March 4 and June 1, forward foreign exchange were valued according to the old method (linearisation of the carry-forward/discount) and a provision for an amount equal to the difference in valuations obtained with the 2 methods was added in the accounting of the funds.

#### Swaps:

"Asset swaps" are valued at the market price according to the maturity of the "asset" remaining and the valuation of the issuer's credit "spread" (or the evolution of its rating).

"Asset swaps" with a maturity of less than or equal to 3 months are valued on a straight-line basis except for exceptional market events.

Asset swaps with a remaining maturity of more than 3 months are valued at market price on the basis of "spreads" indicated by market makers. In the absence of a market maker, "spreads" will be recovered by any means from the available contributors.

Other swaps are valued according to the following rules:

Swaps with a life of less than or equal to 3 months are valued on a straight-line basis. Swaps with a remaining maturity of more than 3 months are valued using the rollover rate method following a zero-coupon curve.

Complex instruments such as "CDS", "SES", or complex options are valued according to their type using an appropriate method.

### Off-balance sheet commitments:

1) Futures:

Commitment = reference price (these are the 5 p.m. prices taken from Bloomberg – Paris time) x contract nominal x quantities.

With the exception of the commitment on EURIBOR contracts traded on the LIFFE which is recorded for its nominal value.

2) Commitments on swap contracts:

a) rate

interest rate swaps with a maturity of less than or equal to 3 months: nominal + accrued interest (interest differential)

unbacked: nominal + accrued interest (interest differential)

interest rate swaps with a life of more than 3 months backed by:

- ° Fixed rate/Variable rate
- valuation of the fixed rate leg at market price
- ° Variable rate/Fixed rate
- valuation of the variable rate leg at the market price

unbacked:

- ° Fixed rate/Variable rate
- valuation of the fixed rate leg at market price
- ° Variable rate/Fixed rate
- valuation of the variable rate leg at the market price

b) other swap contracts

They will be valued at market value.

#### Commitments on conditional futures markets:

Commitment = quantity x nominal of the contract x price of the underlying x delta.

#### Unlisted financial instruments and other securities:

Financial instruments whose price has not been recorded on the valuation day are valued at the last officially published price or at their probable trading value under the responsibility of the management company;

Foreign securities are converted into the equivalent in euros according to the WMR exchange rate on the day of evaluation; Financial instruments not traded on a regulated market are valued under the responsibility of the management company at their probable trading value;

The other financial instruments are valued at their market value calculated by the counterparties under the control and responsibility of the management company.

The valuations of the unlisted financial instruments and of the other securities referred to in this paragraph, as well as the justification for these valuations, are communicated to the statutory auditor during his checks.

#### Swing pricing:

The management company has implemented a net asset value swing pricing mechanism with a triggering threshold since June 20, 2017. This information is made available to unitholders in the fund's term sheet, available at head office of the management company, as well as on its website.

#### Management fees

The management fees are calculated at each valuation on the net assets.

These costs are charged to the profit and loss account of the UCI.

Management fees are paid in full to the management company, which bears all the operating costs of the UCIs. Management fees do not include transaction fees.

The maximum rate applied to the net assets is:

- 1.60% including tax on R, HCHF-R, HSGD-R, and HUSD-R share classes,
- 1.00% including tax on I, HCHF-I, HUSD-I and HAUD share classes,
- 1.10% including tax on the N share class,
- 0.10% including tax on the Q share classes.

#### Performance fee

The performance fee, applicable to a given share class category, is based on the comparison between the valued asset of the fund and the reference asset.

**The valued assets** of the fund are understood as the share of the assets, corresponding to a given share class category, valued according to the rules applicable to assets and after taking into account the actual operating and management costs corresponding to the mentioned share class category.

**The reference asset** represents the share of the fund's assets, corresponding to a share class category, restated for the subscription/redemption amounts applicable to the mentioned category of share at each valuation, and valued according to the performance of the benchmark index (i.e. benchmark rate) corresponding to the share class.

The reference rate for share classes denominated in EUR is equal to:

- capitalised EONIA +3.4% for R shares,
- capitalised EONIA + 4% for I shares,
- capitalised EONIA + 3.9% for N shares.

The performance of the mutual fund is calculated according to the evolution of the net asset value of each class of shares.

The reference rate for share classes denominated in CHF is equal to:

- Libor CHF 1 month + 3.4% for R shares,

- Libor CHF 1 month + 4% for I shares.

The performance of the mutual fund is calculated according to the evolution of the net asset value of each class of shares.

The reference rate for share classes denominated in SGD is equal to:

- SIBOR 1 month +3.4% for R shares.

The performance of the mutual fund is calculated according to the evolution of the net asset value of each class of shares.

The reference rate for share classes denominated in USD is equal to:

- Libor USD 1 month + 3.4% for R shares,

- Libor USD 1 month + 4% for I shares.

The performance of the mutual fund is calculated according to the evolution of the net asset value of each class of shares.

The observation period is defined as follows:

- The first observation period: from September 25, 2020 to the last trading day of June 2022;

- For the following observation periods: from the first trading day of July to the last trading day of June of the following year.

At the beginning of each observation period, the reference asset used will be the highest between the asset recorded on September 25, 2020 and all the valued assets recorded on the last day of each of the observation periods established since the launch of the fund. As the UCITS is the result of a demerger transaction provided for in Article L.214-8-7 of the Monetary and Financial Code, the assets recorded on September25, 2020 will be the highest between the assets recorded on the day of the split and the reference asset of the split H2O VIVACE fund, from which the assets held by the fund "H2O VIVACE SP" (ex H2O VIVACE) have been deducted in due proportion.

The reference asset will, where applicable, be restated for the amounts of subscriptions/redemptions occurring between the date of recognition of this reference asset and the start of the new observation period.

If, over the observation period and for a given share category, the valued asset is higher than that of the reference asset defined above, the variable part of the management fees will represent a maximum of 25% of the difference between these two assets.

If, over the observation period and for a given unit category, the valued asset is lower than that of the reference asset, the variable part of the management fees will be nil.

If, over the observation period, the fund's valued asset is higher than that of the reference asset, this difference will be subject to a provision for variable management fees when calculating the net asset value.

In the event that the fund's valued asset is lower than that of the reference asset between two net asset values, any provision made previously will be readjusted by a reversal of the provision. Provision reversals are capped at the level of previous provisions.

This variable part will only be definitively collected at the end of each observation period if, over the past period, the valued assets of the fund are higher than those of the reference asset at the last net asset value.

In the event of redemption, the share of the provision constituted, corresponding to the number of units redeemed is definitively acquired by the management company.

### Allocation of distributable amounts

#### Definition of distributable amounts:

Distributable sums consist of:

### Income:

Net income is equal to the amount of interest, arrears, premiums and bonuses, dividends, attendance fees and all other income from the securities comprising the portfolio, plus income from temporary cash holdings, minus management fees and borrowing costs. To which it is added retained earnings, plus or minus the balance of the income adjustment account.

#### Capital gains and losses:

Realised capital gains, net of fees, less realised capital losses, net of fees, recorded during the financial year, plus net capital gains of the same nature recorded in previous financial years that were not distributed or capitalised, plus or minus the balance of the capital gains adjustment account.
