What is this product?

Type

This product is a UCITS Fund.

Term

The Fund has no maturity date.

Objectives

Investment objective

The investment objective is to achieve a return greater than the overall US equity market as defined by the S&P 500 Index by primarily investing in US large cap and midcap equities, while seeking to promote environmental, social, and governance ("ESG") characteristics.

Investment approach

The Fund invests primarily in the equity securities of companies established, listed or traded in the United States of America. The Fund's investments undergo an ESG-related review to help to determine their potential eligibility for inclusion in the Fund's investable universe.

Investment policies

The investment policy is based on the expectation that the most effective way to create and sustain wealth in the equity market is to achieve an asymmetric pattern of return over time, where the portfolio aims to go down in value less in times that equity markets decrease in value, while capturing most of the upside performance.

The primary focus of the investment manager is on risk control and declining in value less than the overall US equity market in the down markets. A close second focus is on participation in most up markets. In case this combination of declining less in value in down markets and participation in most up markets is achieved, this is expected to lead to better than market performance over an economic cycle

with less than market risk. Measured over a period of several cycles, the Fund aims to achieve a return greater than the overall US equity market as defined by the S&P 500 Index.

Benchmark

The Fund is actively managed and the choice of investments is not made by reference to a benchmark. The Fund's performance is compared to the S&P 500 Index in SEK (the "Benchmark"). The Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities, which are not constituents of the Benchmark.

Redemption and Dealing shares

You can buy and sell shares on any business day (generally a day in which banks in Ireland or New York are open) on which the value of the shares are calculated,, exceptions to this are more fully described in the fund holiday calendar available from the Administrator.

Distribution policy

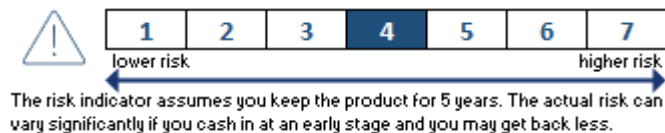
Accumulation shares do not pay dividends. The annual result is capitalised (or reinvested).

Intended Retail Investor

This Fund is designed for retail and institutional investors seeking pooled exposure and who are comfortable with a higher level of investment risk. It is expected that the Fund will be held as part of a diversified portfolio of investments. This Fund has been designed to form part of a broader portfolio of investments. It may also be suitable as a significant component of an investors overall portfolio and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns.

What are the risks and what could I get in return?

Risk



The summary risk indicator is a guide to the level of risk of this product compared to other products.
