This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

What is this product?

Type:

This product is a type of collective investment scheme, specifically, a sub-fund of an Irish authorised undertaking for collective investment in transferable securities (or "UCITS") constituted as an investment company under Irish company law. Your investment will take the form of shares in the Fund.

Term:

The Fund, unless dissolved pursuant to any specific cause set forth in a mandatory law or in accordance with the prospectus of the Fund, is established for an unlimited duration.

Objectives:

The Fund's investment objective is to achieve capital appreciation. To achieve this objective, the Fund will invest in the equities of companies in European Union member states which have adopted the Euro as their currency ("Eurozone"). These shall comprise predominantly common stock, but may also occasionally include American depository receipts, global depository receipts, convertibles and warrants.

Following the selection of the equity securities, a binding decarbonisation overlay strategy will be applied to the portfolio of the Fund to identify securities that will allow the Fund to reduce its carbon exposure compared to the MSCI EMU Index (EUR) - Net Returns (the "Index") and to ensure the Fund will always have no less than a 20% lower aggregate carbon footprint compared to the Index. The Fund will also seek to invest in corporations which follow good governance practices by international standards.

At all times at least two-thirds of the total assets of the Fund (without taking into account ancillary liquid assets) will be invested in equities (excluding convertibles) of issuers domiciled in a country having adopted the Euro as its official currency or exercising the predominant part of their economic activity in such country.

The Fund may invest up to 5% of its assets in warrants, being a form of debenture which gives the right but not the obligation to buy and sell a security before a certain date at a certain price.

The Fund may invest up to 10% of its assets in collective investment schemes.

The Fund will invest up to 10% of its assets in convertible bonds, being a type of bond which can be converted to common stock or cash.

The Fund will invest up to 10% of its assets in securities traded in regulated markets within the EU that have not adopted the Euro.

The Fund may gain market exposure indirectly through the use of specialist financial techniques (known as derivatives). Derivatives may also be used to reduce the Fund's exposures to currency, market and / or interest rate risk, or

to manage the Fund more efficiently.

In order to construct the Fund's portfolio, the Principal Money Manager will appoint one or more Investment Advisers who will provide model portfolios comprised of the securities referenced above. Russell Investments Limited (the "Principal Money Manager") will construct the portfolio based on an aggregation of these model portfolios and may adjust the aggregated model portfolios, using proprietary investment strategies, as required, to enable the management of exposures at a total portfolio level for risk management, return enhancement purposes or to ensure that Fund's environmental and/or social characteristics are achieved.

The Fund is actively managed with reference to the Index. The Fund's performance will be measured against the Index which it seeks to outperform by 2% over the medium to long term. The Principal Money Manager has full discretion to select investments for the Fund and in doing so will take into consideration the Index, but it is not constrained by it.

Income of the Fund will be re-invested to increase the value of your investment.

You may sell your shares in the Fund on any day on which banks are normally open for business in Ireland. For further information please refer to the "Repurchases of Shares" section of the prospectus.

The Fund may be terminated at the discretion of the directors of the Company, provided that a minimum of twenty-one days' written notice has been provided to Shareholders. The Fund may also be terminated by the Shareholders in the Fund, if voted for by at least 75% of the Shareholders in the Fund.

The Fund's depository is State Street Custodial Services (Ireland) Limited (the "Depository").

Intended retail investor:

The Fund is designed primarily for investors seeking capital growth. It should form part of a broader portfolio of investments but may also be suitable as a significant component of an investor's overall portfolio. The Fund is intended for investors with a long term investment horizon and with a preference towards the promotion of environmental characteristics. Investors in the Fund should be prepared to take on a relatively high level of risk of loss to their original capital. For a basic investor, the Fund should be purchased with advice or on an execution only basis.

What are the risks and what could I get in return?

Risk Indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario and the investment is EUR 10,000.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The Fund is designed to be held over the long term.

You can request to take out some or all of your money at any time.

You may exchange shares of one sub-fund for shares in another sub-fund by selling the shares of the first sub-fund and purchasing shares of the other sub-fund as further described in the Prospectus.
