Objectives

The investment objective of the Fund is to seek to generate total returns through income and capital appreciation, while limiting volatility and potential capital losses. The Fund seeks to achieve its objective by actively investing in a diversified range of fixed-income and financial derivative instruments ("FDI"), a majority (not less than 51%) issued by or referencing emerging markets. These include corporate, sovereign and quasi-sovereign entities. The Fund is not managed with reference to a benchmark or index.

Intended Retail Investor

The Fund is intended for all investors seeking capital growth over a long-term investment horizon. Investors should have the ability to bear losses up to the amount they have invested in the Fund. Investors should understand the risks involved and must have prior financial markets experience or knowledge to invest in this Fund.

Key Risks:


- The market value of debt securities is affected by changes in prevailing interest rates. The Fund may also be exposed to credit and default risk by investing in such securities. The default risk increases for below investment grade debt securities.
- The Fund may utilise a number of derivative instruments in managing the Investment Objective of the Fund. The primary risks associated

with the use of such instruments are credit risk, counterparty risk, liquidity risk, legal risk and collateral risk.

- Investments in Russia are currently subject to certain heightened risks with regard to the ownership and custody of securities. In addition, in light of the current ongoing regional conflict in Europe, Russia has been the subject of economic sanctions imposed by countries throughout the world.
- The Manager integrates sustainability risks into the investment processes for the Fund in relation to risk management and decision making. This means sustainability factors are considered as part of the investment process which may carry the risk that the Fund's performance may be negatively impacted due to restrictions placed on its exposure to certain sectors or types of investments as a result.
- Investments in the China Interbank Bond Market through Bond Connect may subject the Fund to additional liquidity, settlement, legal and regulatory risk.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

Performance Scenarios
