#### WHAT IS THIS PRODUCT?

**Type:** Impax Asian Environmental Markets (Ireland) Fund (the "Fund") is a sub-fund of Impax Funds (Ireland) plc, an open-ended investment company with variable capital incorporated in Ireland with registered number 393658. Impax Funds (Ireland) plc is authorised by the Central Bank of Ireland as an umbrella fund with segregated liability between sub-funds and as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. Segregated liability between sub-funds means that the assets and liabilities of each sub-fund are segregated by law. The prospectus and periodic reports are prepared for Impax Funds (Ireland) plc at umbrella level. You may switch your shares in the Fund to shares in other sub-funds in which you are eligible to invest. Further information is available in the prospectus in the section "Subscriptions, Tranfers and Redemptions" under the heading "Conversion of Shares".

**Objectives:** The Fund aims to generate long term capital growth, investing mainly in the shares of publicly quoted companies that conduct their business in the Asia Pacific Region and that provide, utilise, implement or advise upon technology-based systems, products or services in environmental markets. We define environmental markets as:

- Alternative Energy;
- Energy Management & Efficiency;
- Transport Solutions;
- Sustainable Food & Agriculture;
- Water Infrastructure & Technologies;
- Resource Efficiency & Waste Management;
- Digital Infrastructure; and
- Environmental Services & Resources.

The Fund invests mainly in China, Hong Kong, Taiwan, Japan, South Korea, India, Australia, New Zealand, Singapore, Malaysia, the Philippines, and Thailand. Most of these countries are classified as emerging markets, regions of the world that are typically still developing their economies.

Investments will be made on a "long-only" basis and will be predominantly in equity securities. The Fund may utilise equity-linked notes providing economic exposure to underlying shares or securities when it is considered to be impracticable or not in the best interests of the Fund to invest directly in those shares or securities. In particular Impax Asset Management Limited (the "Investment Manager") expects the Fund's investments to include Participatory Notes in order to gain economic exposure to shares and securities in the Indian and Chinese "A" stock markets.

The Investment Manager adds rigorous environment, social and corporate governance analysis for risk management.

Any income the Fund generates for this share class will be reinvested to grow the value of your investment. The Fund is actively managed and is not managed in reference to a benchmark.

You can buy and redeem shares on any day excluding Saturday and Sunday on which banks are normally open for business in Dublin and London. During periods of continuous net subscriptions, an additional charge (anti-dilution levy— maximum 1%) may be payable to cover the costs incurred by the Fund in redeeming investments in the underlying property of the Fund.

In addition to describing the Sterling "S" Accumulation Shares (IE00BJKWZ148), this Key Information Document may also be used as a representative for the Fund's US Dollar "S" Accumulation Shares (IE00BJKWZ585), NOK "S" Accumulation Shares (IE000700X7T2), JPY "S" Accumulation Shares (IE000K1S0L04) and Euro "S" Accumulation Shares (IE00BJKWZ361).

**Intended Retail Investors:** A typical investor in the Fund may be an investor with a medium to long term investment horizon who considers investment in the Fund as a convenient way of seeking to achieve total return through growth of capital and current income through an exposure primarily to equity securities.



## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### **RISK INDICATOR**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

## WHAT HAPPENS IF IMPAX ASSET MANAGEMENT IRELAND LIMITED IS UNABLE TO PAY OUT?

J.P. Morgan SE – Dublin Branch (the "Depositary") will perform safekeeping duties for the Fund's assets. In the event of the insolvency of the PRIIP Manufacturer (Impax Asset Management Ireland Limited), the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from its negligent or intentional failure properly to fulfil its obligations (subject to certain limitations). There is no compensation or guarantee scheme in place which may offset all, or any of, this loss.

## Recommended holding period: 5 years.

The Fund is designed to deliver capital appreciation over a medium to long-term investment horizon and with a medium level of risk You can redeem your shares on a daily basis with no penalty.
