### WHAT IS THIS PRODUCT?

<b>Type:</b>	An umbrella fund constituted as an investment company with variable capital under the laws of Ireland
<b>Term:</b>	The Fund does not have a targeted closure date and may be liquidated at any time, as further detailed in the Prospectus
<b>Objectives:</b>	<p>To seek a maximum total rate of return primarily from current income, while minimising fluctuations in capital values, by investing in short-term Investment Grade fixed income securities.</p> <p><b>Investment Policy:</b> The Fund will invest primarily in an actively managed diversified portfolio of fixed income instruments which are listed or traded on Recognised Markets in North America and Europe. The fixed income instruments in which the Fund invests may include instruments issued by the US Treasury, US Government Agencies, US Government Sponsored Enterprise ("GSE"), US Local, City and State Governments and Agencies and USD denominated fixed income instruments issued by US and non-US corporations, non-US Governments and supranational entities. The fixed income instruments shall include bonds, notes, debentures, treasury obligations, sovereign issues, covered bonds, convertible instruments which are not expected to be materially leveraged, convertible bonds including CoCos which are subject to a limit of 5% of Net Asset Value, commercial paper, certificates of deposit, banker acceptances and other fixed and floating rate income securities. The Fund will invest at least 50% of its Net Asset Value in assets which exhibit positive or improving environmental ("E") and/or social ("S") characteristics.</p> <p>The Fund will invest primarily in Investment Grade instruments, however it may also invest a maximum of 10% of its Net Asset Value in securities rated below Investment Grade subject to these instruments being rated BB- or higher by Standard &amp; Poor's or the equivalent rating of another internationally recognised rating agency. The average portfolio duration of the Fund varies based on the Investment Manager's forecast for interest rates and, under normal market conditions, is expected to range between 0 and 3 years.</p> <p>The Fund may use derivative instruments for both investment and hedging purposes. The return on a derivative is linked to movements in an underlying instrument referenced by the derivative such as currency or interest rates. The base currency of the Fund is USD.</p> <p><b>Share Class Currency Hedging:</b> This Share Class engages in currency hedging using derivative instruments to seek to limit the shareholder's currency risk by reducing the effect of foreign exchange rate fluctuations between the Share Class currency and the base currency of the Fund.</p> <p><b>Distribution Policy:</b> Income will be declared and distributed as a dividend quarterly.</p> <p><b>Dealing Frequency:</b> Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the Prospectus).</p> <p><b>Benchmark:</b> 'Bloomberg Barclays U.S. Government 1-3 Year Index'. The Fund is actively managed and is not designed to track the Benchmark so its performance may deviate materially from the Benchmark. The investment manager has complete discretion in making investments and is not constrained by the Benchmark. The Fund may invest significantly in instruments which are not included in the Benchmark. The Benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, duration, sector weights, country weights, credit ratings and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.</p>
<b>Intended Retail Investor:</b>	The Fund is intended for all investors seeking income from their capital over a short-term investment horizon. Investors should have the ability to bear losses up to the amount they have invested in the Fund. The Fund does not offer capital protection.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

## WHAT HAPPENS IF BARING INTERNATIONAL FUND MANAGERS (IRELAND) LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are segregated from those of Baring International Fund Managers (Ireland) Limited. The Depositary is responsible for the safekeeping of the Fund's assets. To that effect, if Baring International Fund Managers (Ireland) Limited defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk of the Fund suffering some loss in case of default of the Depositary. You may face a financial loss if your broker or the entity from whom you purchased the Fund was to default.

As an investor in the Fund, there is no compensation or guarantee scheme in place.
