What is this product?

Type

This is an open-ended UCITS fund.

Objectives

The Fund seeks to provide long term capital growth by investing mainly in a portfolio of approximately 30 to 80 companies from around the world that the Investment Manager considers to be undervalued.

The Fund mainly invests in companies located in, or primarily doing business from, countries in the Morgan Stanley Capital International Emerging Markets and the Morgan Stanley Capital International Frontier Markets indices. These are typically areas around the world that are still developing. Pzena Investment Management LLC (the "Investment Manager") uses thoughtful research to carefully consider the value of an entire business relative to its stock price. The Fund is actively managed which means that the Investment Manager uses its expertise to pick investments to achieve the objective of the Fund.

Benchmark

As an actively managed fund, the MSCI Emerging Markets Index Net w/h is used as a benchmark for performance comparison purposes only; the performance of the Fund may differ significantly from that of the performance comparison index.

Currency

The reference currency of the Fund is USD. The share class currency is USD.

Term

This Fund is an open-ended UCITS and has an indefinite duration. The Fund may be terminated at any time in line with the constitutional documents of the Fund.

Intended Investor

The Fund is suitable for institutional investors seeking capital appreciation, with a long-term investment horizon and who are prepared to accept a level of volatility. This Fund may not be appropriate for investors who plan to withdraw their money within 5 years. The Investment Manager has a long-term approach to investing. Please refer to the Prospectus and supplements for specific details on how to submit an application to buy Shares of the Fund.

Subscription and Redemption

You can buy and sell Shares on any day (excluding Saturday and Sunday) on which banks are normally open for business in New York. 

What are the risks and what could I get in return?

Risk indicator
