What is this product?

Type

This product is a UCITS Investment Fund.

Term

This product has no fixed end date. However the Sub-Fund, at its absolute discretion, can redeem all the shares of the Sub-Fund under the circumstances set out in the prospectus.

Objectives

Investment objective The investment objective of the Sub-Fund is to seek long-term growth of capital and income.

Investment policies The Sub-Fund is an index tracking fund. It is passively managed and will seek to achieve its objective by investing predominantly in global equity and equity related securities that as far as possible and practicable reflect the component global equity securities of the MSCI World ex Selected Securities Index, unhedged as measured in USD (the "Index"). The Index is a broad global equity benchmark that represents large and mid-cap equity performance across a range of developed markets except for those companies which the index provider excludes based on negative environmental and social screens. It is currently anticipated that the tracking error of the Sub-Fund will be up to 50 bps under normal market conditions. Tracking error is an indicator of the degree to which the Sub-Fund's performance may deviate from that of the Index. The causes of tracking error can include but are not limited to: holdings/size of the Sub-Fund, cash flows, such as any delays in investing subscription proceeds into the Sub-Fund or realising investments to meet redemptions, fees and the frequency of rebalancing against the Index.

The Sub-Fund will seek to promote environmental and social characteristics within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR").

The Sub-Fund's environmental characteristics are to avoid investment in companies that generate more than 1% of their revenue from thermal coal extraction, arctic drilling or oil tar sand mining.

The Sub-Fund's social characteristics are to avoid investment in companies which are involved in the manufacture, distribution or sales of controversial weapons, or which manufacture tobacco products or generate more than 50% of their revenue from tobacco distribution or sales. Further, the Sub-Fund will invest at least 20% in sustainable investments, being investments which, according to the Investment Manager's framework: (a) contribute positively to UN Sustainable Development Goals ("SDGs"); (b) do no significant harm to any environmental or social objective; and (c) follow good governance practices.

The Sub-Fund seeks to achieve its environmental and social characteristics by investing in the component securities of the Index which applies a negative environmental and social screen in line with the environmental and social characteristics of the Sub-Fund.

The Sub-Fund follows good governance standards in the selection of securities for investment and seeks to engage with any companies, identified as violating UN Global Compact Principles ("UNGC"), to remediate where possible. UNGC is a set of globally accepted standards on human rights, labour, the environment and anti-corruption.

The Sub-Fund may use optimisation techniques in order to achieve a similar return to the Index; this strategy seeks to build a representative portfolio that matches the risk and return characteristics of the Index (provided that any such investments are not, at the time of purchase, inconsistent with the negative screening criteria of the Index), without the expectation that the Sub-Fund will hold every underlying constituent of the Index. This approach may result in the Sub-Fund investing in only a relatively small number of Index constituents where such instruments provide similar performance.

Equity securities in which the Sub-Fund will invest will generally be listed on recognised markets across developed markets and will include, without limitation, common stocks, new issues, convertible bonds, and warrants.

The Sub-Fund will invest at least 90% of its net assets in securities issued in markets which are listed as developed markets under the rules of the Index and/or constitute recognised markets. No more than 5% of the net assets of the Sub-Fund may be invested in aggregate in securities issued in markets other than those listed as developed markets by a global equity index provider such as, without limitation, MSCI or FTSE.

Investment by the Sub-Fund in REITs listed on recognised markets will not exceed 10% of the Sub-Fund's net asset value.

The Sub-Fund may only use financial derivative instruments (instruments for which the price is dependent on one or more underlying asset, "FDI") for the purposes of hedging and efficient portfolio management. FDI may enable the Sub-Fund to obtain market exposure in excess of the value of the Sub-Fund's assets. The Sub-Fund may not invest in FDI that would result in losses exceeding the net asset value of the Sub-Fund.

The Sub-Fund may, on an ancillary basis, invest in debt securities issued or guaranteed by EU Member States and non-EU Member States.

The Sub-Fund may invest in cash, money market instruments and/or liquid instruments such as bank deposits, certificates of deposit, fixed and floating rate instruments, commercial paper, floating rate notes and freely transferable promissory notes which may be listed on recognised markets for liquidity purposes and for paying expenses due by it.

Redemption and Dealing You can buy and sell shares in the Sub-Fund on demand each day which is a bank business day in Ireland or the United Kingdom ("Dealing Day").

Distribution Policy The Share Class will not distribute dividends. Income and capital gains from the Sub-Fund are reinvested.

Intended retail investor

Investors who have at least a basic understanding of financial markets and the underlying investment instruments, who understand the risk of the Sub-Fund including the risk of capital loss and that the product should not constitute a complete investment plan and:

- have a long term investment horizon
- seek a product which promotes environmental and/or social characteristics

Depository The Sub-Fund's assets are held through its depository, State Street Custodial Services (Ireland) Limited.

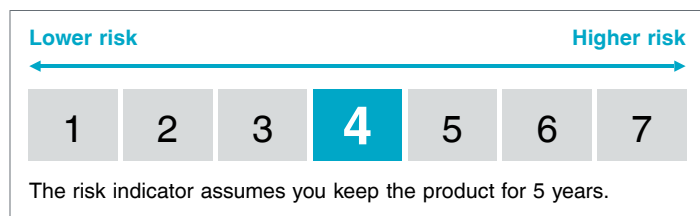
Further information This document describes a Share Class of the Sub-Fund, which is a sub-fund of MGI Funds plc constituted as an umbrella, comprising a number of sub-funds (including the Sub-Fund), each having a separate portfolio of assets. However, MGI Funds plc is a single legal entity that may operate, have assets held on its behalf, or be subject to claims in other jurisdictions that may not necessarily recognise such segregation. Accordingly, there is no absolute certainty that the assets of a sub-fund will not be exposed to the liabilities

of other sub-funds of MGI Funds plc. Investors do not have the right to exchange shares in one sub-fund for shares in another sub-fund. What are the risks and what could I get in return?

Risk Indicator

Performance scenarios

What happens if Mercer Global Investments Management Limited is unable to pay out?

The Sub-Fund is responsible for paying redemptions and any other payment obligations due to investors. The Manager is not responsible for meeting the obligations of the Sub-Fund to investors from its own assets. The Sub-Fund's assets are safeguarded by the Depositary in accordance with applicable law. If the Sub-Fund is unable to pay out to investors due to its insolvency, investors will be unsecured creditors in the insolvency process and are likely to suffer a financial loss. Investors may also suffer a financial loss in the event of the Depositary's insolvency or default (or that of any custody delegate). Investors in UCITS, such as the Sub-Fund, are not covered under the terms of the Irish statutory investor compensation scheme.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product is designed for long term investment; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on any Dealing Day provided written instruction is received by the Administrator before 1pm (Irish time). It will typically take 3 Business Days for you to be paid.
