What is this product?

Type

- This product is a class of units of the Sub-Fund and is denominated in EUR. The Fund is an open-ended undertaking for collective investment (Fonds Commun de Placement or "FCP") and qualifies as an Undertaking for Collective Investment in Transferable Securities ("UCITS"), subject to Part I of the Luxembourg law of 17 December 2010 relating to Undertakings for Collective Investment ("Investment Fund Law"), transposing Directive 2009/65/EC related to UCITS.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

Objectives

Investment objective:

■ The objective of the Sub-Fund is to achieve capital appreciation by investing two third of its assets in mid and long term investment grade bonds, traded on the Euroland financial markets, and issued by corporates or by European national governments, European governments agencies and supranational organisations located in Europe.

Investment policy:

- The Sub-Fund is actively managed in reference to the benchmark ICE BofAML Euro Broad Market Index (EUR unhedged) (the "Benchmark"). For the construction of the portfolio, the Benchmark serves as reference in terms of overall exposure to risk factors including country, interest rate and credit position. Amplitude of deviations from the Benchmark varies depending on the degree of conviction of the investment manager.
- Bonds denominated in EUR and issued by non Euroland issuers are as well permitted. Bonds not denominated in EUR might be invested in provided that the currency risk is hedged. The remaining portion of the assets may be invested in others type of bonds (such as but not limited to convertible bonds, below investment grade bonds, zero coupon bonds).
- The Sub-Fund seeks to invest mainly in bonds with a good Environmental, Social and Governance criteria ("ESG") profile, "green bonds" and "social bond", based on the Investment Manager's in-house research and/or third party ESG ratings. The Sub-Fund promotes, amongst others, some ESG characteristics in compliance with Article 8 of SFDR but does not have sustainable investment as its objective. An exclusion list will further be followed by the investment manager.

- Financial techniques and instruments for hedging and/or non-hedging purposes may be used.
- Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 3 years.

Subscription and Redemption: Investors can buy or sell units of the Sub-Fund every day which is a bank business day in Luxembourg ("Business Day").

Distribution Policy: Income generated by the Sub-Fund is reinvested and included in the value of units.

Intended investor

Category R will be available for any kind of investors.

It is suitable for every type of relatively expert investors who wish to pursue well-defined investment objectives. No special experience is required in matters of capital market products.

The minimum subscription is EUR 500.

Term

The Sub-Fund was incorporated for an undefined period. The manufacturer may terminate this product unilaterally under the conditions set forth in the prospectus of the Fund.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years.



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we, as the management company acting on behalf of the Fund, are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the Sub-Fund to pay you.

This product is in this category because it invests in a range of assets with different levels of risk and its simulated and/or realised return has experienced a medium-low level rises and falls historically.

Not all risks affecting the Sub-Fund are adequately captured by the summary risk indicator.

This rating does not take into account other risk factors which should be considered before investing, these include: financial, economic and political risks, credit risk, use of derivative instruments, interest rate risk and holding of convertible bonds.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we, as the management company acting on behalf of the fund, are not able to pay you what is owed, you could lose your entire investment.

Performance scenarios

How long should I hold it and can I take money out early?

Recommended holding period ("RHP"): 3 years

The RHP has been defined by taking into account the above objectives and risk and reward profile. You should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Redemption requests must be received before 2 p.m. Luxembourg time on each Business Day to be dealt with on the basis of the net asset value per unit applicable on that day ("Valuation Day"). Payment for redemptions is expected to be made within 1 week from the Valuation Day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.
