What is this product?

TYPE OF PRODUCT

The product is a sub-fund of Lemanik SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

OBJECTIVES

The Fund aims to seek a consistent, absolute return while placing emphasis on the preservation of capital in the medium-term. The Fund's long-term objective is to realise an annualized total return of 3% above the return of the daily-capitalized Euro short-term rate ("€STR") index.

The Fund will invest in equities and debt securities, as well as money market instruments, without geographical restriction. The Fund may invest in these securities directly or may invest indirectly through derivatives or by investing in UCITS, UCIs and/or Exchange Traded Funds (ETF).

The Fund may also use derivatives for investment purposes or in seeking to reduce or cancel out its exposure to various investment risks (hedging).

The Fund will use total return swaps to gain exposure to eligible indices related to equity, FX, interest rates and credit (corporate and government bonds) in emerging markets.

The Fund may take exposure to commodities, using in particular eligible transferable securities which do not embed a derivative and/or derivative instruments on eligible diversified commodity indices and other eligible underlying assets, in each case in compliance with applicable risk diversification requirements. No direct exposure to physical commodities will be taken by the Fund.

To achieve its investment goals, for treasury purposes and/or in case of unfavourable market conditions, the sub-fund may invest in money market instruments and deposits on an ancillary basis.

During exceptional market conditions, the Fund may invest up to 100% of its net assets in cash and cash equivalents, term deposits, debt securities and money market instruments dealt on a Regulated Market and whose maturity does not exceed 12 months, monetary UCITS and UCIs. Term deposits and liquid assets may not exceed 49% of the Fund's net assets.

Sale of shares in the Fund can be made on any business day. The Fund is actively managed and references Euro short-term rate ("€STR")(the "Benchmark") for performance comparison purposes. The Benchmark only consists in an outperformance target for the Fund. Shareholders' attention is drawn to the fact that the Benchmark is not an index which integrates environmental and social considerations.

Sale of shares in the Fund can be made on any business day.

The Fund does not intend to distribute dividends. Any income arising from the Fund's investments is reinvested and reflected in the value of your shares. However, the annual general meeting of shareholders may decide to distribute such income.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 1 year.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 1 year.

What happens if Lemanik Asset Management S.A. is unable to pay out?

Lemanik Asset Management S.A. is not making any payment to you in relation to this Fund and you would still be paid in case of a default from Lemanik Asset Management S.A.

The Fund's assets are held with CACEIS Investor Services Bank S.A. and are segregated from the assets of other sub-funds of the Company. The assets of the Fund cannot be used to pay the debts of other sub-funds of the Company.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.

The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 1.1% before costs and -4.2% after costs.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 1 year.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible every Bank Business Day (a day on which banks are generally open for business in Luxembourg). All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 2 p.m (Central European time) on one (1) Bank Business Day preceding the relevant Valuation Day (each Bank Business Day). Redemption proceeds shall be paid in the relevant reference currency usually within three (3) Bank Business Days following the relevant Valuation Day.

How can I complain?
