## What is this product?

### Type

This is an investment fund established as a Company With Variable Capital (SICAV).

### Objectives

**Investment objective** The Sub-Fund will invest in bonds or other fixed income transferable securities issued by corporations, by countries' treasuries and/or government agencies and/or by supranational organizations (such as EBRD or World Bank or the EIB).

**Investment policies** The Sub-Fund will have no constraint on the rating of the bonds it is investing in up to 100% of the Sub-Fund's net assets may be invested in non investment grade bonds, including bonds issued in Emerging Countries.

The Sub-Fund will invest in various types of transferable securities such as fixed and floating rate bonds, indexed bonds (i.e. bonds the performance of which is linked to an index of transferable securities) and subordinated bonds and up to 25% of its net assets in convertible and cum warrants bonds.

The Sub-Fund will invest up to 10% of its assets in UCITS and/or other UCIs. In addition, the Sub-Fund may also invest up to 10% of its net assets in listed equities, equity related-securities and derivatives worldwide.

The Sub-Fund may also invest up to 20% of its net assets in contingent convertibles ("CoCos") and up to 10% of its net assets in eligible assets with underlying commodities.

In addition, the Sub-Fund may also use, for the purpose of efficient portfolio management, proxy hedging and investments, currency forwards and options, as well as listed futures (and related options) on government bonds, interest rates and currencies.

Participation in the options, forwards or futures markets, equity indices and in currency exchange transactions involves investment risks and transaction costs to which the Active European Credit Sub-Fund would not be subject in the absence of the use of these strategies.

The Active European Credit Sub-Fund may, on an exceptional and temporary basis hold up to 100% of its assets in cash and cash equivalents.

**Benchmark** The Sub-Fund is actively managed without reference to any benchmark.

**Redemption and Dealing** Investors may purchase or sell shares of the Sub-Fund on any business day in Luxembourg.

**Distribution Policy** Any income generated by the Sub-Fund is reinvested to grow the value of the shares.

**Launch date** The Sub-Fund was launched on 10/11/2003 and the share class was launched on 18/03/2008.

**Fund Currency** The base currency of the Sub-Fund is EUR.

**Conversion of units/shares** Shareholders are allowed to request the conversion of all or part of their shares into shares of another class/sub-fund subject to the conditions and fees detailed in the prospectus of the Fund.

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 4 years and are prepared to take on a low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

The Fund is open-ended and has no maturity date. The manufacturer, Compass Asset Management S.A., is not entitled to terminate this product unilaterally, and the Fund cannot be automatically terminated.

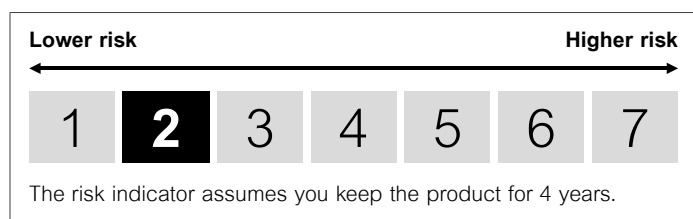

## What are the risks and what could I get in return?

We have classified this product as 2 out of 7, which is a low risk class.

### What happens if Compass Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

Investors may purchase or sell shares of the Sub-Fund on any business day in Luxembourg.
