What is this product?

TYPE OF PRODUCT

The product is a sub-fund of UNI-GLOBAL, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

OBJECTIVES

The Sub-Fund offers the chance to take advantage of the opportunities that arise on the world equity markets. The Sub-Fund seeks to build up a portfolio offering the best possible ratio between the estimated risk and the expected return. The Sub-Fund invests according to an active approach which involves identifying the portfolio with the optimum estimated risk for the universe in question.

The Sub-Fund is actively managed and references MSCI ACWI Index (the "Index") for comparison purposes only. The Investment Manager has full discretion with regard to the implementation of the Sub-Fund's investment strategy, which is not linked to the Index. There are no restrictions on the extent to which the Sub-Fund's portfolio and performance may deviate from the ones of the Index.

The Sub-Fund promotes environmental and social characteristics according to article 8 of the Regulation (EU) 2019/2088.

The Sub-Fund consists of equities or other capital stock (e.g. shares in cooperatives, participation or bonus certificates, etc.) and any other holdings, known as transferable securities, without geographical or currency restriction.

The Sub-Fund may also invest up to 30% of its total net assets in China AShares through the use of the Stock Connect and in China H Shares.

The Sub-Fund invests at least 51% of its net assets in these equities or capital stock.

The Investment Manager mandatorily applies on a continuous basis an ESG integration and risk management methodology to determine the eligibility of companies for investment in the Sub-Fund so as to enhance the portfolio towards assets with better ESG scoring and try to reduce exposure to assets with worst ESG scores.

Some of the markets in these countries are not currently considered as regulated markets pursuant to the article 41 (1) of the UCITS Law, and investments in these markets, together with investments in unlisted securities, must not exceed 10% of the Sub-Fund's net assets.

Russia is one such market, with the exception of the Moscow Interbank Currency Exchange ("MICEX-RTS"), which is considered as a regulated Russian market on which direct investments may exceed 10% of net assets.

The Sub-Fund may hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes.

In order to achieve its investment goals, the Sub-Fund may hold a maximum of 10% of its net asset value in units of UCITS or other UCIs.

In order to achieve its investment goals, the Sub-Fund may invest up to 10% of its net asset value in REITs.

The Sub-Fund may use derivatives to hedge against currency risk, and/or to enhance effective management.

The share class is denominated in EUR.

The Sub-Fund is denominated in USD

The currency risk of this share class is hedged.

These shares are capitalisation shares. Income and capital gains are reinvested.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 6 years.

What are the costs?

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 6 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible every Bank Business Day (any full day on which banks are open for business in Luxembourg and New York). All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 12 p.m (Central European time) on one (1) Bank Business Day preceding the relevant Valuation Day (every Bank Business Day). Redemption proceeds shall be paid in the relevant reference currency usually within three (3) Bank Business Days following the relevant Valuation Day.

How can I complain?
