This product is authorised in Luxembourg and is regulated by the Commission de Surveillance du Secteur Financier (CSSF) in respect of this Key Information Document.

#### 1. What is this product?

**Product Type:** The Fund is an actively managed Undertakings for Collective Investments in Transferable Securities (UCITS) ETF under Luxembourg law in the form of a sub-fund of a Société d'Investissement à Capital Variable (SICAV).

Maturity: This product has no specific maturity date. However, this product may be dissolved or merged, in which case you will be informed by any appropriate means provided for by the regulations.

**Objectives:** The investment objective of OSSIAM EUROPE ESG MACHINE LEARNING (the "Fund") is to generate net total return on a selection of equities listed in Europe. The Fund is actively managed and will only use its benchmark index, the Solactive Europe 600 Index NTR (the "Benchmark Index"), to compare performance and carbon emissions. The composition of the Fund's portfolio is therefore not constrained by the Benchmark Index and may deviate significantly from the constituents of the Benchmark Index.

**Investment Policy:** The objective of the Ossiam Europe ESG Machine Learning investment fund is to generate net total return from a selection of equities listed in Europe. The fund's investment process is systematic. Several ESG filters are in place to exclude companies :

Involved in the controversial arms, tobacco or coal sectors ;

• Which are the subject of serious ESG controversies ;

• Which are in violation of at least one principle of the UN Global Compact ;

• Which are on Norges Bank Investment Management's exclusion list.

The remaining stocks are then classified as financial opportunities or risks based on their ESG profile by Ossiam's machine learning algorithm. The final portfolio is made up of stocks qualified as opportunities, weighted to minimize volatility and meet the ESG objectives below.

The portfolio's ESG score must be 10% higher than the investment universe (Solactive Europe 600 Index), with a 40% reduction in greenhouse gases, lower carbon intensity (measured by the total amount of greenhouse gases emitted divided by the company's revenue) and reduced emissions from fossil fuel reserves.

#### Allocation of distributable amounts: Capitalization.

**Intended Investors:** Investors who understand the Fund's risks and plan to invest for the long term (minimum 5 years). The Fund is aimed at investors who : (i) are looking for a growthoriented investment with a sustainable investment approach, (ii) are interested in exposure to European equity markets, either as a core investment or for diversification purposes, (iii) have a high risk profile and can withstand substantial losses. The shares of this Fund have not been registered under the "US Securities Act of 1933" and may not be offered or sold directly or indirectly for the account or benefit of a "U.S. Person" as defined by US "Regulation S" and/or the "Foreign Account Tax Compliance Act".

In view of the provisions of EU Regulation No. 833/2014 and EU Regulation 2022/398 the subscription of shares in this Fund is prohibited to any Russian or Belarusian national, any natural person residing in Russia or Belarus or any legal person, entity or body established in Russia or Belarus except nationals of a Member State and natural persons holding a temporary or permanent residence permit in a Member State.



### 2. What are the risks and what could I get in return?

#### **Risk Indicator**



The risk indicator assumes that you hold this product **for 5 years.** The real risk may be very different if you opt to exit before maturity, and you may get less in return. The risk indicator allows you to assess the level of risk of this product compared with others. It indicates the probability of this product incurring losses in the event of market movements or our inability to pay you.

We have classified the Fund in risk class 4, which is a medium risk class. In other words, the potential losses linked to the product's future results are at a medium level,

and if the situation were to deteriorate on the markets, it is possible that our ability to pay you could be affected. The market liquidity risk could amplify the variation of product performances.

Beware of currency risk. If the sums paid to you are in another currency, your final profit will depend on the exchange rate between the two currencies. This risk is not taken into account in the above indicator.

# 3. What happens if the Issuer is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the portfolio management company. # 4. What are the costs?

Reduction in yield (RIY) shows the impact of the total costs you pay on the return on investment you could achieve. Total costs take into account one-off, ordinary and ancillary costs.
