What is this product?

Type

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Indian bonds and other similar securities.

Investment Policy:

The Fund will normally invest at least 90% of its assets in: investment and non-investment grade, as well as unrated Indian domestic bonds and similar securities denominated in Indian Rupee (INR). These will be government, supranational and/or corporate issues; investment and non-investment grade, as well as unrated bonds and similar securities issued or guaranteed by the government or government agencies of India, as well as by companies which carry out most of their business in India, that are denominated in other currencies; other instruments referencing underlying exposure to INR bonds; cash and cash instruments up to a maximum of 20% of assets.

The Fund may be subject to a limit on its investments in India. Where this is the case, the Fund may invest in non-INR denominated securities outside of India.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund may invest up to 100% in securities issued or guaranteed by the Indian government or Indian government agencies.

The Fund may invest up to 10% of its assets in contingent convertible securities. However, this exposure is not expected to exceed 5%.

The Fund may invest up to 10% of its assets in other funds, including other funds of HSBC, and may invest in bank deposits, money market instruments or money market funds for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives and use them for hedging and efficient portfolio management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- ◆ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.

- ◆ The reference currency of the Fund is USD. The reference currency of this share class is USD.
- ◆ Income is reinvested.
- ◆ You may sell your investment on most working days.
- ◆ The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, Crisil Composite Bond Dollar Index.
- ◆ The reference benchmark has a high level of concentration. This means that a small number of securities make up a significant proportion of the benchmark.

Intended Retail Investor

The Fund may be suitable for investors with a long term investment horizon and is intended for investors aiming for exposure to asset classes which may be subject to moderately high volatility. The Fund may be suitable for investors looking for an investment to complement an existing core portfolio or as a standalone investment to gain exposure to a specific asset class.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.

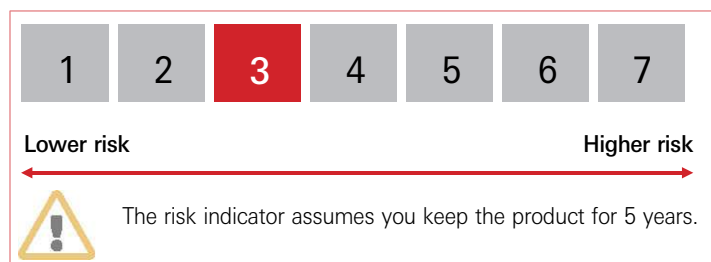

What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depository Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depository if the assets of the Fund are lost. The Depository is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law. In the event of a bankruptcy or insolvency of the Depository Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- ◆ In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
