What is this product?

Type This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

To provide long-term capital growth on your investment by investing in shares of companies located in the Balkan region.

At least 75% of the sub-fund's assets shall consist of shares and equity related instruments.

The sub-fund will invest at least 50% of its assets in companies located in Albania, Austria, Bosnia-Herzegovina, Bulgaria, Cyprus, Greece, Croatia, Hun-gary, Macedonia, Montenegro, Romania, Serbia, Slovakia, Slovenia, the Czech Republic and Turkey.

The sub-fund may also invest in companies not located in the aforementioned countries but which exercise a significant part of their economic activity there.

Benchmark: The portfolio is actively managed on a discretionary basis with reference to a benchmark. While the product compares its performance against the STOXX Balkan Total Market Index, it does not try to replicate this bench-mark and freely selects the securities that it invests in. The deviation with this benchmark can be significant.

Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 5-10 years.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.
