What is this product?

Type

This product is a fund of Nordea 1, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The fund is established for an unlimited duration.

The Board of Directors may compulsorily redeem or merge all the shares of the fund or share class. Circumstances under which such decision would occur are available in the fund's prospectus and accessible via www.nordea.lu. "Legal" section.

Objectives

Investment Objective The fund's objective is to provide shareholders with investment growth in the medium to long term.

Investment Strategy In actively managing the fund's portfolio, the management team selects securities that appear to offer superior investment opportunities.

Investment Policy The fund mainly invests in Danish covered bonds. Specifically, the fund invests at least two thirds of total assets in covered bonds that are issued by public authorities, or by companies or financial institutions that are domiciled, or conduct the majority of their business, in Denmark. The fund's major part of currency exposure is hedged to the base currency, although it may also be exposed (through investments or cash) to other currencies.

Derivatives: The fund may use derivatives for hedging (reducing risks), efficient portfolio management and to seek investment gains.

Risk Indicator

Base Currency: The fund is denominated in DKK. Investments in this share class settle in JPY. This share class seeks to largely protect its performance against the DKK/JPY fluctuations.

This is a currency hedged share class and seeks to hedge the NAV, expressed in the fund's base currency, to the currency of the share class. It is important to note that the hedge is not perfect, especially during times of market volatility. Mainly due to interest rate differentials and costs associated with performing the hedging activity the currency hedged share may have a somewhat different performance to the equivalent share class in the base currency.

Intended retail investor

This share class is not intended to retail investors and solely accessible to institutional investors under the conditions set out in the fund's prospectus and/or specific agreement. This share class is intended for institutional investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely.
