What is this product?

This is an investment fund established as a Company With Variable Capital (SICAV).

Objectives

Investment objective This Sub-Fund is a feeder sub-fund and will as such at all times invest at least 85% of its assets in units of the Master Fund (EDM INVERSION, FI) which qualifies as a "master UCITS".

The objective of this Sub-Fund is to achieve capital appreciation through investment in the Master Fund.

Investment policies The Sub-Fund intends to realise its investment objective by investing substantially all of its assets into the units of the Master Fund. The Master Fund will invest in Euro equities.

The residual assets of the Sub-Fund will consist in ancillary liquid assets, as may be required from time to time for dealing liquidity purposes and payment of costs and expenses of the Sub-Fund. The Sub-Fund intends to minimize the level of ancillary liquid assets held for these purposes.

Description of the Master Fund

The Master Fund uses the General Index of the Madrid Stock Exchange "IGBM" as a benchmark index to merely informative and comparative effects.

A minimum of 75% of the Master Fund's total exposure and 90% of the equity will be equity listed in Spanish markets and assets from Spanish companies listed in other markets, of mainly high capitalisation, without discarding those of low capitalisation. The possibility to invest in smallcap assets can negatively influence the Master Fund's I liquidity. The remainder of the Master Fund will be invested in fixed-income assets, specifically public or private fixed income, including deposits and money market instruments, listed or otherwise, with a maximum exposure of 25% of the total Master Fund. The average term of the fixed-income portfolio of the Master Fund is not predetermined. Issues will be required to have a minimum average credit rating (minimum BBB-). However, up to 100% may always be invested in assets with a rating equal to or greater than that of the Kingdom of Spain at all times. The management company will not invest in those issues that in its opinion have a lower credit quality than that issued by credit rating agencies. The exposure to currency risk will not exceed 30%. The Master Fund will not invest more than 10% of its equity in units of financial collective investment undertakings (CIU) which are qualifying assets, harmonised or otherwise, belonging or otherwise to the manager's group, with an investment policy consistent with that of the Master Fund.

The maximum exposure of the Master Fund to market risk through derivatives is the amount of the equity.

The Master Fund may operate with derivative financial instruments traded in organised derivative markets for hedging and investment purposes and with OTC derivatives for hedging purposes. This operation entails risks due to the possibility that the hedging is not perfect, the leverage involved and the lack of a clearing house.

The Master Fund I promotes, among other characteristics, environmental and social characteristics, but does not have as its objective a sustainable investment.

The Sub-Fund promotes, among other characteristics, environmental and social characteristics according to article 8 of the SFDR, but does

not have as its objective a sustainable investment . Nonetheless, it remains exposed to Sustainability Risks. Such Sustainability Risks are integrated into the investment decision making and risk monitoring to the extent that they represent a potential or actual material risks and/or opportunities to maximizing the long-term risk-adjusted returns.

The Sub-Fund considers PAIs by integrating relevant ESG factors alongside traditional financial factors as part of its due diligence, research and ongoing monitoring of individual issuers and via engagement with those issuers. Such Sustainability Risks are integrated into the investment decision making and risk monitoring to the extent that they represent a potential or actual material risks and/or opportunities to maximizing the long-term risk-adjusted returns.

This Sub-Fund is highly diversified. Therefore, it is expected that the Sub-Fund will be exposed to a broad range of Sustainability Risks, which will differ from company to company. Some markets and sectors will have greater exposure to Sustainability Risks than others. However, it is not anticipated that any single Sustainability Risk will drive a material negative financial impact on the value of the SubFund.

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of directors of the Fund as set forth in the Fund prospectus, the Fund cannot be

automatically terminated. The manufacturer, Waystone Management Company (Lux) S.A., is not entitled to terminate the product unilaterally.

What happens if Waystone Management Company (Lux) S.A. is unable to pay out?
