What is this product?

This product is a fund of Nordea 2, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The fund is established for an unlimited duration.

Objectives

Investment objective The fund's objective is to provide shareholders with investment growth in the medium to long term.

Investment Strategy In actively managing the fund's diversified portfolio, the management team selects securities that appear to offer superior investment opportunities. The team targets modest levels of return above the fund's benchmark.

Investment policy The fund mainly invests in emerging market bonds denominated in hard currencies. Specifically, the fund invests at least two thirds of total assets in debt securities, and credit default swaps, that are denominated in hard currencies (such as USD and EUR). These securities are issued by public authorities or quasi-sovereign issuers, or by companies that are domiciled, or conduct the majority of their business, in emerging markets. The fund is allowed to invest directly into Chinese Debt Securities via CIBM or via Bond Connect. The fund's main currency exposure is to the base currency, although it may also be exposed (through investments or cash) to other currencies.


