## WHAT IS THIS PRODUCT?

**Type:** GAMCO ALL CAP VALUE (the "Fund") is a sub-fund of GAMCO International SICAV an investment company organised as a société anonyme under the laws of the Grand-Duchy of Luxembourg with registered number B155657 and qualifies as a société d'investissement à capital variable (SICAV) subject to Part I of the Law of 17 December 2010 on undertakings for collective investment. The assets and liabilities of each sub-fund are segregated from those of other sub-funds; there is no cross-liability, and a creditor of one fund has no recourse to the other sub-funds. The prospectus and periodic reports are prepared for GAMCO International SICAV at umbrella level. You may switch your shares in the Fund to shares of the same class in other sub-funds in which you are eligible to invest. Further information is available from CACEIS Investor Services Bank S.A. (the "Administrator").

**Objective:** The Fund's objective is to seek growth of capital. Current income, to the extent it may affect potential growth of capital, is a secondary objective.

**Investment policy and strategy:** The Fund is actively managed by Gabelli Funds LLC (the "Investment Manager") without reference to a benchmark. The Fund will invest its net assets in transferable securities which shall include, primarily, a broad range of readily marketable equity securities consisting of common stocks, preferred stocks and securities that may be converted into common stocks of United States ("Convertible Securities") companies on an All Cap basis (i.e. without restriction on market capitalisation of the company – "all cap") that are listed on a recognized securities exchange or similar market. The Fund may also invest in securities outside the United States. The Fund seeks to achieve its primary investment objective by making investments based on the Investment Manager's perception of companies that are selling at substantial discounts to their Private Market Value ("PMV"). PMV is the value the Investment Manager believes informed investors would be willing to pay for an entire company; the sum of its parts, plus a strategic premium in a strategic or financial transaction. The Fund is actively managed without reference to a benchmark.

**Hedging:** The shares are denominated in Swiss Franc (CHF) and are hedged. The base currency of the Fund is USD. The Fund will enter into currency hedging in relation to this share class which aims to protect investors from movements in the CHF exchange rate in relation to the Fund's assets denominated in currencies other than the CHF.

The Fund may use derivatives as an alternative to direct exposure but not to seek additional gains. The Fund's expected use of total return swaps ("TRS") and securities lending is expected to be 0% of net assets but may be up to 5% of net assets. Leverage will not be employed by the Fund.

This share class is a distribution share class. Income from the Fund's investments may be paid as a dividend.

You may request redemption of your shares on any day which is a full banking day in both New York City and Luxembourg City and are ordinarily processed the following business day.

**Intended Retail Investors:** This Fund is suitable for all investors who:

- understand the risks of the Fund, plan to invest for the medium to long term, and are looking for investment growth,
- are interested in value-oriented investment that favours US-listed equities,
- have a high-risk profile; and
- can bear significant temporary losses.

**Term:** The Fund has no maturity date. The Management Company is not entitled to terminate the Fund unilaterally nor can the Fund be automatically terminated.

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs.
