What is this product?

Type

Share of a sub-fund part of an umbrella fund in corporate form.

Term

This product does not have a maturity date, the competent body of the PRIIP (as identified in the offering documentation) is entitled to terminate the product. The amount you would receive in the event of such termination might be lower than the amount you invested.

Objectives

Investment objective The objective of the Fund is to outperform its Benchmark and provide a long-term capital appreciation by investing, with a socially and Responsible Investment (SRI) process in listed equities from European companies that offer solutions for ageing societies through their products and services, as further detailed in the Supplement of the Fund. The Sub-Fund is a SRI labelled European thematic equity and while it does not have as its objective sustainable investment, the Sub-fund promotes ESG characteristics pursuant to Article 8 of the SFDR.

Investment policy The Fund promotes social characteristics, through investing in listed companies that contribute to the social objectives linked to the long-term trend of ageing population, those social objectives being: Health, Ageing Well, Better Living and Social solutions to the challenges of an ageing world. Moreover, the fund is structured around 3 investment pillars, being Healthcare, Pension & Savings and Consumers. The Fund shall invest at least 90% of its net assets in listed equities issued by European companies compliant with the SRI process. For the purposes of the Sub-fund, European companies are companies listed on a stock exchange, or incorporated, in the European Union, Great Britain, Norway and Switzerland. The Fund may also invest up to 10% of its net assets in equities issued worldwide, (subject to the same SRI process described for European companies), money market instruments, government bonds, corporate bonds, convertibles and participation rights that are not subject to the above SRI process. The Fund shall not invest more than 10% of its

net assets into other funds. Such Funds must benefit or have undertaken to benefit within one year from the French SRI label and/or French Greenfin label and/or any equivalent foreign labels, codes or charters.

Benchmark MSCI Europe – Net Total Return Index The Fund is actively managed and references the Benchmark by seeking to outperform it. The Investment Manager has full discretion over the composition of the Fund's portfolio and there are no restrictions on the extent to which the Fund's portfolio and performance may deviate from the ones of the Benchmark.

Redemption policy The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

Distribution policy The Share Class makes no dividend payment. Earned income is retained and reinvested.

Derivatives policy The Fund may use financial instruments and derivatives for hedging purposes, for efficient portfolio management purposes and for investment purposes. The underlying of such derivatives are subject to the above SRI process. The use of derivatives must be compliant and consistent with the Fund's long-term objectives.

Intended retail investor

The Fund expects that a typical investor in the Sub-fund will be a long term investor who knows and accepts the risks associated with this type of investment. It is designed to form part of a portfolio of investments.

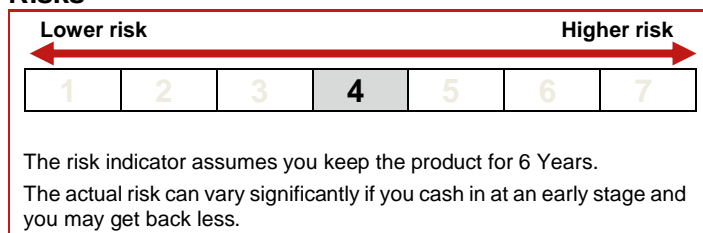
