#### What is this product?

#### Type

This is an open ended UCITS fund.

#### Term

The fund is established for an unlimited period. In certain circumstances the fund may be unilaterally terminated in accordance with legal requirements.

#### Investment objective

The fund aims to deliver income and capital growth by investing in a diversified range of assets and markets worldwide.

The fund is actively managed and invests at least two-thirds of its assets directly or indirectly through derivatives in equities, bonds and alternative asset classes

The fund may invest:

- up to 50% of its assets in sub-investment grade bonds (being bonds with a credit rating below investment grade as measured by Standard & Poor's or any equivalent grade of other credit rating agencies) and unrated securities.

- in excess of 50% of its assets in emerging market bonds.

- up to 20% of its assets in asset-backed securities and mortgage-backed securities.

The fund may also invest up to 15% of its assets in mainland China through Regulated Markets (including the CIBM via Bond Connect or CIBM Direct).

The fund may invest indirectly in alternative asset classes such as commodities or real estate through derivatives, investment funds or structured securities.

The fund may invest up to 10% of its assets in open-ended investment funds. The fund may invest in money market investments and hold cash.

The fund may use derivatives, long and short, with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets

#### Intended retail investor

The fund will be suitable for investors who desire a sustainable level of income with some capital growth, offered through investment in a range of asset classes. The fund is intended for retail investors who have a basic investment knowledge and an ability to bear large short-term losses. This investment should form part of a varied investment portfolio. ## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

The fund's assets are held in safekeeping by its depositary, so the fund's ability to pay out would not be affected by the insolvency of Schroder Investment Management (Europe) S.A. #### Costs over time
