What is this product?

The product is a share class of the sub-fund Templeton Global Bond Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS. Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Investment Objective

The Fund is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to maximise total investment return by achieving an increase in the value of its investments, earning income and realising currency gains over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

• debt securities of any quality issued by governments and governmentrelated entities located in any developed or emerging markets

The Fund can invest to a lesser extent in:

debt securities of any quality issued by corporations located in any country

• debt securities of supranational entities, such as the European Investment Bank

 \bullet Mainland China through the Bond Connect or directly (less than 30% of assets)

securities in default (limited to 10% of assets)

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes which are used as an active investment management instrument to gain exposure to markets.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Intended retail Investor

The Fund may appeal to investors looking to maximise their investment return with a combination of income, capital appreciation and currency gains by obtaining exposure to debt securities issued by governments and government-related entities worldwide as well as derivatives and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who have an some knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
