What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

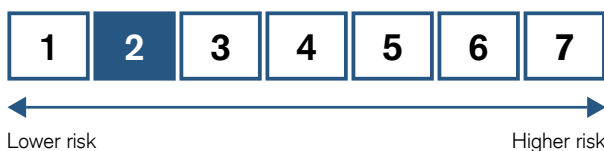
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed without reference to a benchmark aiming to provide its investors with an attractive income and capital appreciation, seeking to capture alpha through a combination of capital structure positioning, relative alpha strategy and opportunistic trading. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. The Sub-fund will invest, directly or indirectly in a diversified portfolio of fixed or variable rate debt and debt-related securities from 40% to 100%. The Sub-fund will also invest up to 60% in equity and equity-related securities including ordinary shares and common stocks, preferred shares, convertible preference shares warrants rights and American Depositary Receipts (ADRs), Global Depositary Receipts (GDRs), European Depositary Receipt (EDR) and closed ended Real Estate Investment Trusts (REITS). Moreover, the Sub-fund may invest up to 100% in High Yield bond. These investments will have no sector nor geographical restriction. The Sub-fund may invest in non-investment grade debt securities, up to 20% of its assets in convertible bonds or CoCos Bonds in aggregate and target funds and/or Financial Derivatives Instruments ("FDI"). This Share Class does not make regular distributions. The investor can buy or sell units of the Fund on a daily basis, as further defined in the prospectus. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
