The Product is a sub-fund of EDMOND DE ROTHSCHILD FUND, a public limited liability company (société anonyme), incorporated as a "société d'investissement à capital variable" under Part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment and qualifying as an undertaking for collective investment in transferable securities (UCITS)

#### Objectives

Objective: The Product's objective is to outperform its benchmark through exposure to equity markets, primarily in the Eurozone, by selecting securities on a discretionary basis in an investment scope comparable to its benchmark.

Benchmark index: The benchmark index is the MSCI EMU (NR) Index. The benchmark index will be expressed in the class currency.

The benchmark index of the Product serves only for comparison purposes. The Product is actively managed.

Investment policy: The investment manager will systematically include ESG factors in its financial analysis in order to select the highest-rated companies.

At least 90% of the companies in the portfolio will have an ESG rating. At the end of this process, the Product will have an ESG rating that is greater than that of its investment universe.

The actual risk can vary significantly if you cash in at an early stage and you may get back less. In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator),

Credit risk: When a significant level of investment is made in debt securities.
