## What is this product?

Type

The Fund is an investment company with variable capital (société d'investissement à capital variable, SICAV) established for an unlimited period of time on 21 July 2015 in the form of a public limited company (société anonyme, S.A.) under Luxembourg law in accordance with the provisions of the Luxembourg law of 10 August 1915 (the "1915 Law") on commercial companies, as amended (the "1915 Law"), and Part I of the Luxembourg law of 17 December 2010 (the "2010 Law").

Term

The term of the Fund is unlimited, so there is no maturity date. The Fund may be dissolved and liquidated under the specific circumstances set out in the Articles of Incorporation.


Objectives

The sub-fund is actively managed. Over the long-term the sub-fund seeks to achieve the best possible return and to outperform the benchmark of the sub-fund. To achieve the investment objective, at least 51% of the net asset value will be invested in Bonds and currency exposure covering risk from the Emerging and Frontier Markets. The investment strategy is a macro-economically and fundamentally driven approach with a long-term investment horizon (the so called "traffic lights approach"). Investments are identified through a qualitative and quantitative decision-making process in local currency frontier market government bonds and money market instruments. The investment universe includes AAA supranationals and more than 90 EM and Frontier sovereign markets to the extent and as long as the requirements of Article 41 I c) of the Law of 2010 are satisfied. Derivative instruments may also be used for investment purposes to take currency risk. Investments in equities and securities with equity character will not be undertaken. The benchmark for the sub-fund is: 100% JPM GBI EM Diversified TR (SEK). The focus is on absolute return (benchmarkaware, not driven), inflation expectations and real yields. The strategy targets higher risk adjusted total returns with lower FX volatility through diversification and off- benchmark exposures. The investment strategy will restrict the extent to which the portfolio holdings may deviate from the benchmark. This deviation may be material. The benchmark index for the sub-fund is determined by the SICAV and may be changed if necessary. Income shall remain in the sub-fund (or: in this unit class) and shall increase the value of the shares. This key information document describes a subfund of a fund. The Prospectus and the annual and semi-annual report are prepared for the entire fund. The assets and liabilities of each sub-fund are segregated from those of the other sub-funds of the fund. The shareholder has the right to switch his shares in one sub-fund into shares of another sub-fund. For further information about how to exercise that right, please refer to the detailed description in the prospectus. Where different share classes are offered within the sub-fund, an exchange of shares from one share class for shares in another share class within the sub-fund is possible, so long as the investor fulfils the conditions of the respective share class. In this case no exchange commission is charged. Depositary of the fund is State Street Bank International GmbH, Luxembourg Branch. Intended retail investor

The fund is designed for investors who are capable of assessing the risks and value of the investment. The investor must be prepared and able to accept significant fluctuations in the value of the shares, and the potential of a significant loss of capital. The assessment of the SICAV should not be considered investment advice; instead, it is intended to provide the investor with an initial point of reference for determining whether the fund is appropriate for their investing experience, risk tolerance and investment horizon.

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you. Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. If we are not able to pay you what is owed, you could lose your entire investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average, and best performance of UI - Aktia EM Frontier Bond+ IX (SEK)/ 100% JPM GBI EM Global Diversified TR (EUR) over the last 12 years. Markets could develop very differently in the future.

## What happens if the Manufacturer is unable to pay out?

## How long should I hold it and can I take my money out early?

#### Recommended holding period: 7 Years

This product does not have a mandatory holding period. The recommended holding period is based either on historical data or the Manufacturer's estimate regarding the average fluctuation in the unit value, which is to be expected for this product. If you, as an investor, have a shorter investment horizon, the risk is on average higher that at the time of redemption, the unit value of the product will be lower than when you invested. There are no redemption costs or fees. However, you may return the product in accordance with the procedures indicated in the Sales Prospectus.
