## What is this product?

**Type:** Shares of a Sub-Fund of Amundi Funds, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

**Objectives:** Seeks to increase the value of your investment (through income and capital growth) over the recommended holding period, while achieving an ESG score greater than that of its investment universe.

**Benchmark:** Euro Short Term Rate (ESTER) Index. Used for performance comparison.

**Portfolio holdings:** The sub-fund is actively managed. It mainly invests in corporate and government bonds, money market instruments and deposits. These investments may be anywhere in the world, including emerging markets. The bond investments may be below investment grade and denominated in any OECD currency, in particular EUR. The sub-fund may or may not hedge currency risk at the portfolio level, at the discretion of the investment manager. The sub-fund uses derivatives to reduce various risks (hedging), manage the portfolio more efficiently, and gain exposure (long or short) to various assets, markets or other investment opportunities such as credit, equities, interest rates and foreign exchange.

**Management process:** In actively managing the sub-fund, the investment manager uses analysis of markets and individual issuers to identify those bonds that appear to offer the best risk-adjusted returns (top-down and bottom-up approach). The investment manager is not constrained by the benchmark for the construction of the portfolio and makes its own investment decisions.

The sub-fund promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

**Intended Retail Investor:** This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment and to receive income over the recommended holding period with the ability to bear losses up to the amount invested.

**Redemption and Dealing:** Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the Amundi Funds prospectus.

**Distribution Policy:** As this is a non-distributing share class, investment income is reinvested.

## What are the risks and what could I get in return?

### RISK INDICATOR



The risk indicator assumes you keep the product for 4 years.

The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs.
