What is this product?

Type: Shares of a Sub-Fund of AMUNDI INVESTMENT FUNDS, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: Seeks to increase the value of your investment over the recommended holding period.

The Sub-Fund invests mainly in a broad range of bonds and money market securities from government, corporate and other issuers from anywhere in the world, including emerging markets. The Sub-Fund invests in a broad range of sectors. The Sub-Fund makes extensive use of derivatives to reduce various risks, for efficient portfolio management or as a way to gain exposure (either long or short) to various assets, markets or income streams. This may generate a high level of leverage. In particular, the Sub-Fund will invest in short and medium-term interest rate swaps.

Benchmark : The Sub-Fund is actively managed and is not managed in reference to a benchmark.

Management Process : The Sub-Fund integrates Sustainability Factors in its investment process and takes into account principal adverse impacts of investment decisions on Sustainability Factors as outlined in more detail in section "Sustainable Investment" of the Prospectus.

The investment manager employs a top-down approach to identify an attractive risk/return trade-off across countries and global sectors, represented by a series of directional and relative value investments. The investment manager pursues other investment strategies to diversify sources of return or mitigate risk. The investment manager pursues a flexible asset allocation strategy.

This is a non-distributing share class. Investment income is re-invested.

The minimum recommended holding term is 6 years.

Investors may sell on demand on any business day in Luxembourg.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the AMUNDI INVESTMENT FUNDS prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.
