What is this product?

Type

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Asian bonds, while promoting environmental, social and governance (ESG) characteristics. The Fund's ESG rating is calculated as a weighted average of the ESG ratings given to the issuers of the Fund's investments, and it aims to be higher than the weighted average of the constituents of the reference benchmark.

The Fund promotes ESG Characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing/policies.

Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in investment grade, non-investment grade bonds and unrated bonds, and other similar securities issued by governments, government-related entities and supranational entities and companies, that are based in Asia.

The Fund will invest at least 70% of its assets in investment grade, non-investment grade bonds and unrated bonds, and other similar securities issued by issuers meeting certain environmental, social and governance ESG rating and lower carbon intensity criteria (ESG and Lower Carbon Criteria).

ESG and Lower Carbon Criteria, together with fundamental qualitative issuer analysis, are used to determine the Fund's investible universe, that excludes: issuers involved in the production of controversial weapons and tobacco; with more than 10% revenue generated from thermal coal extraction and with more than 10% revenue generated from coal-fired power generation; but may include issuers following good ESG practices and sustainable bonds. The Fund conducts enhanced due diligence on bonds issuers that are considered to be non-compliant with the UN Global Compact Principles. The Investment Adviser takes consideration of both the carbon intensity and the overall ESG rating of each issuer, the latter being calculated based on the issuer's Environmental (E), Social (S) and Governance (G) ratings and their respective weights, which are not subject to the aforementioned exclusions specific to the issuer's sector. Please refer to the Prospectus for more details on ESG and Lower Carbon Criteria, and Excluded Activities.

The Fund may invest up to 30% of its assets in onshore Chinese bonds traded on the China Interbank Bond Market (CIBM) and will not invest more than 10% in unrated Chinese onshore bonds.

The Fund will invest up to 40% in securities that are rated below investment grade and may also invest in bank deposits and money market instruments for treasury purposes.

The Fund may invest up to 10% of its assets in securities issued by a single sovereign issuer, up to 10% of its assets in asset backed securities (ABS) and mortgage-backed securities (MBS), up to 10% in convertible bonds and up to 10% in other funds.

The Fund may invest up to 10% of its assets in contingent convertible securities. However, this is not expected to exceed 5%.

The Fund's primary currency exposure is to US Dollar (USD) denominated bonds. Non-USD exposure currencies including Asian currencies will be limited up to 30% of its assets.

The Fund may invest in derivatives and use them for hedging and efficient portfolio management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- ◆ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- ◆ Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency SGD and the base currency of the Fund USD. However, exchange rate fluctuations between the base currency of the Fund and the currencies of the Fund's assets will not be protected.
- ◆ Income is reinvested.
- ◆ You may sell your investment on most working days.
- ◆ The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, JP Morgan ESG Asia Credit.
- ◆ The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a material percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- ◆ The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.

Intended Retail Investor

The Fund may be suitable for investors with a long term investment horizon and is intended for investors aiming for exposure to asset classes which may be subject to moderately high volatility. The Fund may be suitable for investors looking for an investment to complement an existing core portfolio or as a standalone investment to gain exposure to a specific asset class.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.

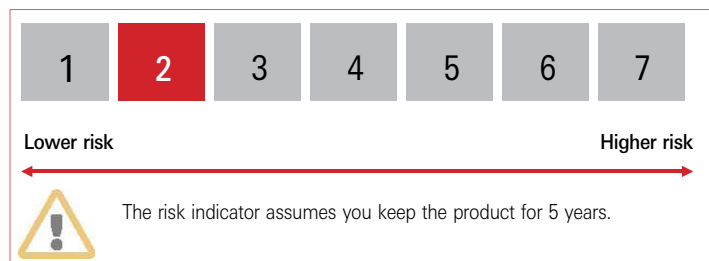

What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depository Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depository if the assets of the Fund are lost. The Depository is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law.

In the event of a bankruptcy or insolvency of the Depository Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- ◆ In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- ◆ SGD 10,000 is invested.
