What is this product?

Type

The product is a share of the sub-fund Franklin Innovation Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions led down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size and located anywhere in the world, that are leaders in innovation, take advantage of new technologies and benefit from new industry conditions

The Fund may from time to time hold a significant amount of cash or cash equivalent where the manager believes that the markets or economic conditions are unfavourable for investors.

The Fund can invest to a lesser extent in:

- money market instruments, short-term US government securities, high-grade commercial paper and/or bank obligations
- units of other mutual funds and exchange-traded funds (limited to 5% of assets)

The innovation-focused portfolio may emphasize sectors such as, for example, information technology (including software and internet), communications services and health care (including biotechnology). The investment team focuses on companies meeting its criteria of sustainable growth driven by innovation. The Fund may have a substantial part of its portfolio invested in companies located or traded in the US.

The benchmark of the Fund is the Russell 1000 Growth Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Processing of subscription and redemption orders

You may request the sale of your shares on any Luxembourg business day.

Intended retail investor

The Fund may appeal to investors looking to capital appreciation by investing in equity securities of companies whose growth prospects are poised to benefit from dynamic technology and innovation and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who have a basic knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

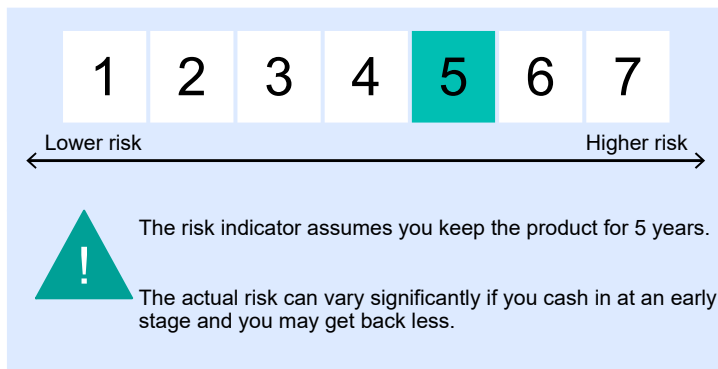

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund. The assets of the Fund are held separately by the Fund's appointed depository, i.e. J.P. Morgan SE, Luxembourg branch. The depository is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations. (Cash could however be lost in case of default of the depository or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depository.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
