## What is this product?

## Туре

The Product is a share of the Sub-fund Wellington US Brand Power Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) III SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and is authorised under Part I of the 2010 Law and qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

## Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

## Objectives

The Fund seeks long-term total returns in excess of the S&P 500 Index ("Index"), primarily investing in US companies where brands are key determinates of long-term value.

The Fund will be actively managed, based on the view that strong, well-led brands are evergreen "patents" which can create demand, drive higher margins and returns on invested capital, and provide competitive advantages that can be hard for others to duplicate. The Investment Manager also believes strong brands can perform well in strong economic conditions but also show resilience during more difficult market conditions. Research is focused on identifying companies with strong brands (measured in terms of pricing power, gross margins, active loyalty, global reach, brand life cycle, and royalty relief valuation (a methodology used to derive a value for a brand)) and attractive fundamentals (improving quality metrics, attractive upside/downside, capital allocation decisions, management track record and earnings revisions) in order to build a portfolio of companies with strong brands but poor fundamentals as well as companies with strong fundamentals but poor brand strength.

The Fund is unconstrained by market capitilisation and sector, but is expected to have a bias towards large-cap companies.

The Fund will be concentrated in the number of individual companies held and should be expected to have low turnover. The Fund may invest in non-US companies, subject to a maximum 10% of the Fund's net asset value.

The Index serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index. The Index is designed to measure performance of the broader US equity market.

The Fund will invest in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts. The Fund may invest either directly or via derivatives.

While there are no restrictions on the Fund's ability to use derivatives for investment purposes (such as gaining exposure to a security), derivatives are mainly used to hedge (manage) risk.

The Fund will support certain environmental characteristics by maintaining a carbon footprint (weighted average intensity) that is at least 50% lower than the Index.

The currency of this Share class is different to the base currency of the Fund and so the performance of the Share class will be subject to the impact of the movement of the exchange rate between the currencies.

# Income policy

Any income allocated to the Share class from the  $\ensuremath{\mathsf{Fund}}$  is reinvested.

#### **Dealing Frequency**

Shares can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

#### Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio.

## Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
