## What is this product?

**Type**

The product is a share of the sub-fund Wellington Asia Credit Income Fund (the "Fund") (the "Share Class") which is part of the Umbrella Fund, an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and qualifies as an undertaking for collective investment in transferable securities (UCITS) subject to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 as amended from time to time. The Fund is a compartment of the Umbrella Fund, meaning its assets and liabilities are segregated, by law, from those of other compartments of the Umbrella Fund. The performance of other compartments has no impact on the performance of the Fund.

**Term**

The Umbrella Fund and the Fund do not have a fixed term or maturity period. Subject to the termination rights of the directors of the Umbrella Fund as set forth in the "Liquidation of Funds" section of the prospectus of the Umbrella Fund (the "Prospectus"), the Fund cannot be automatically terminated. The management company of the Umbrella Fund (the "Management Company") may not unilaterally terminate the Fund.

**Objectives**

The Fund seeks long-term total returns, with a secondary focus on regular income.

The fund will invest primarily directly or indirectly, in a diversified portfolio of Asian domiciled, US dollar-denominated credit instruments, whilst also aiming to deliver a consistent level of income. Issuers will be located primarily in the Asia ex-Japan region and may include (but are not limited to) corporates, sovereign, and quasi-sovereign and supranational debt securities, currencies, and derivatives. The Fund may also invest up to 30% of its net asset value in local currency Asia ex-Japan debt instruments however a maximum of 20% of the Fund's net asset value may be unhedged to the Fund's base currency.

The Fund will aim to declare a distribution of between 4%-7% of the Fund's net asset value in USD on an annual basis, dependent on market conditions, however this is not guaranteed.

The weighted average credit quality of the Fund will typically be investment grade i.e. at or above Baa3 by Moody's, BBB- by Standard & Poor's, or BBB- by Fitch. However, the Fund's average credit quality may be below investment grade from time to time as a result of credit downgrades, rating removal, default or in certain market conditions that the Investment Manager deems appropriate. The fund may also invest in below investment grade and unrated debt securities.

The Fund is not constructed relative to an index, but the J.P.Morgan Asia Credit Index Diversified (the "Index") serves as a reference benchmark for weighted average carbon intensity purposes in line with the Fund's Net Zero Commitment. Whilst the Fund's securities may be components of the Index, the Index is not considered during portfolio construction and the investment manager of the Fund (the "Investment Manager") will not manage the extent to which Fund securities differ from the Index.

The Investment Manager excludes investment in the worst rated corporate and quasi-sovereign issuers for Environmental (E) or Social (S) characteristics relative to their peer universe. In order to do this, the Fund assigns corporate and quasi-sovereign issuers an individual E and S Rating, based on Wellington Management's proprietary ratings framework, using a rating scale of 1-5, where 1 is the highest rating, and excludes corporate and quasi-sovereign issuers that have received an E or S Rating of 5.

The Investment Manager will seek to reduce the Fund's carbon footprint as measured by its weighted average carbon intensity (WACI) to net zero by 2050, or sooner, in line with the Paris Agreement. The Investment Manager will manage the Fund towards this 2050 net zero commitment by reducing the Fund's WACI by no less than 50% below the Index's 2019 WACI by 2030 and aim to achieve net zero by 2050. As an interim milestone, the Investment Manager is committed to limit the Fund's contribution to climate change by targeting a WACI that is at least 30% less than the Index's 2019 WACI baseline as it transitions towards its 2030 and 2050 carbon reduction goals.

The Fund applies a number of exclusionary screens in order to avoid or reduce certain harmful impacts on the environment and society. A full list of these exclusion can be found in the Fund's pre-contractual disclosure document within the prospectus.

A minimum of 67% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

This Share class will, via derivatives, seek to provide similar performance to the Fund in its base currency by limiting the impact of the movement of exchange rates between the currency of the Share class and the base currency of the Fund.

**Income policy**

Any income allocated to the Share Class from the Fund is distributed.

**Dealing frequency**

Shares can be bought or sold daily in accordance with the prospectus of the Umbrella Fund (the "Prospectus"). The base currency of the Fund is USD.

**Intended retail investor**

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss.

**Conversions**

You may convert your shares into shares of another class / compartment of the Umbrella Fund provided that you meet the criteria for investment in that other class. No conversion charge will be charged by the Fund, but, you may be charged a fee by your advisor or financial intermediary. These third party costs are not reflected below. You can find further information about your right to convert shares in the Prospectus.

## What are the risks and what could I get in return?

## What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the management company of the Umbrella Fund (the "Management Company"), the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. ## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The board of directors of Umbrella Fund shall redeem shares of any Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
